Mayor Burke reviewed the Engineer's report. Deputy Mayor Lubitz had a few questions regarding the joint effort with Frenchtown's, and Kingwood's Public Works Department pertaining to the repair of Horseshoe Bend Road. Mayor Burke reviewed a conversation he had with the Township's Engineer Tom Decker, and noted that Mayor Sworen reported that he is working on the project. Mayor Burke will contact Mayor Sworen regarding Horseshoe Bend Road to discuss how the progress is going. Mayor Burke explained that the Public Works Department would need approximately \$20,000 for the materials for the road. He explained that Tumble Falls Road has been paved and it should be completed in a few weeks after the installation of the guiderail. There was a discussion regarding the Ukarish property and the wells. Mayor Burke responded by stating that there is enough water after the testing for approximately eight wells, but he is not sure if there have been perks for eight units yet. Mayor Burke noted that he met with the Township's C.F.O. D. Laudenbach before the meeting to see if they could come up with some transfers.
