Notice is hereby given that the said Ordinance will be considered for final passage at a public hearing to be held on 7th day of September, 2017 at a meeting beginning at 7:00 PM at the Municipal Building located on the corner of County Road 519 and Oak Grove Road, Kingwood Township, New Jersey, at which time all interested persons will be heard.**

**ORDINANCE NO. 19 – 12 - 2017**

**AN ORDINANCE TO PROVIDE FOR THE CONSTRUCTION OF A 16 X 50 ADDITION TO THE EXISTING MORTON BULDING LOCATED AT THE HORSESHOE BEND PARK AS A GENERAL IMPROVEMENT FOR THE TOWNSHIP OF KINGWOOD IN THE COUNTY OF HUNTERDON AND STATE OF NEW JERSEY AND APPROPRIATING \$15,500.00 FROM THE CAPITAL IMPROVEMENT FUND**

**BE IT ORDAINED** by the Township Committee of the Township of Kingwood, in the County of Hunterdon, State of New Jersey as follows:

**SECTION 1.** The improvement described in Section 2 of this Ordinance is hereby authorized as a general improvement to be made or acquired by the Township of Kingwood, New Jersey. For the said improvement or purposes described in Section 2, there is hereby appropriated the sum of \$15,500.00, said sum being inclusive of all appropriations heretofore made therefore.

**SECTION 2.** The Township of Kingwood is hereby authorizing the construction of a 16 x 50 addition to the existing Morton Building located at the Horseshoe Bend Park.

**SECTION 3.** In order to finance the cost of the construction of a 16 x 50 addition to the existing Morton Building located at the Horseshoe Bend Park there is hereby appropriated \$15,500.00 from the Capital Improvement Fund.

**SECTION 4.** The said purpose described in Section 2 of this Ordinance is not a current expense and is an improvement which the Township may lawfully acquire or make as a general improvement.

**SECTION 5.** The capital budget of the Township of Kingwood is hereby adopted to conform with the provisions of this Ordinance. The project has been included in the 2017 Capital Budget of the Township of Kingwood.

**SECTION 6.** There is no debt authorized for this improvement or purpose.

**SECTION 7.** This Ordinance shall take effect immediately upon final passage according to law.
