BY THIS DOCUMENT, I/WE, THE UNDERSIGNED, PROVIDE OFFICIAL NOTICE TO THE FEDERAL ENERGY REGULATORY COMMISSION (FERC) AND ALL MEMBERS OF THE PENNEAST PIPELINE COMPANY, LLC, ITS REPRESENTATIVES, CONTRACTORS, SUBCONTRACTORS, AFFILIATES, ASSOCIATES AND AGENTS OF THE FOLLOWING :

I/WE AFFIRMATIVELY DECLARE MY/OUR INTENT TO DENY ANY AND ALL ACCESS TO THE PROPERTY SET FORTH BELOW. I/WE RENEW AND AFFIRM ANY AND ALL PRIOR NOTICE DENYING ACCESS TO PENNEAST, ITS AGENTS AND ASSIGNEES, TO ENTER MY/OUR LANDS FOR ANY AND ALL PURPOSES INCLUDING, BUT NOT LIMITED TO, SURVEYING OR INVESTIGATING MY/OUR PROPERTIES IN CONNECTION TO THE PENNEAST PIPELINE PROJECT.

ANY ENTRY ONTO MY/OUR PROPERTIES IS UNAUTHORIZED AND WILL BE TREATED AS TRESPASS UPON MY/OUR LANDS IN VIOLATION OF STATE AND LOCAL LAW AND WILL BE REPORTED TO APPROPRIATE LAW ENFORCEMENT AUTHORITIES IMMEDIATELY.

ANY INFORMATION OBTAINED AND SUBMITTED BY THE PENNEAST PIPELINE COMPANY, LLC. OR ITS AGENTS AND ASSIGNEES CONCERNING THE PROPERTY AT THE ADDRESSES SET FORTH BELOW HAS BEEN OBTAINED WITHOUT MY/OUR PERMISSION AND IS THEREFORE, ILLEGALLY OBTAINED. SUCH INFORMATION MUST BE DISREGARDED BY FERC IN ITS ANALYSIS OF THE PENNEAST PIPELINE PROJECT PROPOSAL.

I/WE STRONGLY OPPOSE THE PENNEAST PIPELINE PROJECT DUE TO ITS DEVASTATING IMPACT ON OUR LANDS, OUR ENVIRONMENT, OUR LOCAL ECONOMY AND THE SAFETY, HEALTH AND WELFARE OF OUR FAMILIES AND COMMUNITIES.
