NEW AND PENDING MATTERS

Resolution No. 2011 – 11 - Sundancer Capital LLC - Block 24, Lots 4 & 7 – Muddy Run Road and Barbertown Point Breeze Road – Preliminary Approval

D. Pierce stated he distributed a revised resolution with the changes that were requested by the applicant, which upon review, were appropriate. Most of the changes were ministerial, such as capitalizing the word “Applicant” one was to remove as a condition the submission of materials demonstrating that any and all electrical equipment will not interfere with radio and television transmission or reception, change the color of the material in the fence to earthtone, change the affordable housing language to reflect the current status of the law, consolidate some language on the phasing of the construction and combined several elements into one so the applicant can proceed simultaneously and will be done before the actual installation of the racking system.

It was moved by P. Lubitz, seconded by M. Synchron and carried to adopt Resolution No. 2011 – 11 - Sundancer Capital LLC - Block 24, Lots 4 & 7 – Muddy Run Road and Barbertown Point Breeze Road – Preliminary Approval.

After some discussion on prohibiting work on Sundays, J. Mazawey, the applicant’s attorney, stated the applicant agrees to no work being performed on Sundays.

All members present voted **AYE** on **ROLL CALL VOTE**, except D. Haywood, T. Kratzer and J. Strasser, who **ABSTAINED**.
