

To: Street Graphic Applicants

Re: Street Graphic Application

When submitting an application, the following information/documentation must be submitted. The omission of any one of these items will automatically constitute an incomplete application, and all materials will be returned for revision and re-submission.

- 1. Name, address and telephone number of the applicant;**
- 2. Application fee of \$75.00 per graphic;**
- 3. Location of building or structure and block and lot number to which or upon which the graphic is to be attached;**
- 4. Position of the graphic in relation to nearby buildings, structures, signs, banners, etc.**
- 5. Twelve (12) copies of plans drawn to scale and specifications, including size, color of the graphic and its various parts, materials of which the graphic is to be constructed, style of lettering, information to be displayed and method of attachment to the buildings or into the ground;**
- 6. Color sketch of the graphic and building(s) as they would appear in relation to each other;**
- 7. Method of illumination and intensity of the light;**
- 8. Name, address and telephone number of the person erecting the graphic;**
- 9. Written consent to the owner of the building, structure and/or land to which or upon which the graphic is to be erected;**
- 10. For any ground graphics with a surface area of more than 32 square feet or the bottom of which is situated five (5) feet or more above the ground, a copy of stress sheets and calculations showing that the structure is designed for dead load and wind pressure in any direction in the amount required by the New Jersey Uniform Construction Code;**
- 11. Proposed landscaping, if applicable;**
- 12. Determination of whether or not the application requires site plan review;**
- 13. Sign permit applications must be notarized;**
- 14. Such other information pertaining to the proposed street graphic as may be reasonably required by the Planning Board;**
- 15. Electronic copy of application and all attachments;**
- 16. Submission two weeks prior to the Planning Board meeting.**
