Grants

ANJEC Smart Growth Grant for Open Space & Recreation Plan.

• Completed Open Space & Recreation Plan (written by Banisch Associates) May 2011.

Recycling

An EC member is the recycling coordinator (Cynthia Niciecki):

- Attended Hunterdon County Solid Waste Advisory Committee (SWAC) meetings.
- Was a member of recycling subcommittee of SWAC.
- Collected & submitted recycling figures to the state: 2010 tonnage report: 4,780 tons (more than twice the amount reported in 2009, which was 2,284 tons).
- Coordinated pick-up of recycling bins when full—about every 1 to 2 weeks & removed non-recyclables when possible.
- Added electronics recycling container (provided free of charge by DonJon) Note A New NJ law requires that electronics be recycled and not placed in garbage.
- Continued scrap metal dumpster (Twp gets paid for metal by M&A).
- Continued clothing/shoe bin (free collection by a non-profit, Planet Aid).
- Discontinued battery recycling due to fire hazard (and no longer accepted by Hunterdon County).
- Event recycling receptacles—used at Community Day & available for other events.
- Submitted quarterly municipal recycling report to Hunterdon County (required by County).

EC members volunteered for Saturday morning hours. Removed non-recyclables when possible.

Updated recycling instruction sheet, which was mailed to all residents & available on the website.

Updated an alphabetical list of recyclables and where/how they may be recycled for the website.

Camera purchased and installed at the Recycling Center.

Open Space and Parks & Recreation

Worked with the Open Space Committee and Parks & Recreation Committee to update of the Open Space & Recreation Plan (written by consultant Banisch Associates) (completed May 2011).

Trash Handling on Open Space Properties - purchased "Carry in/Carry out" signs purchased and posted at Horseshoe Bend Park, Lockatong Preserve and Idell Preserve.

Provided support, advice and labor for an Eagle Scout Project at Kingwood Park – installation of a Native Plant Rain Garden.

Assisted with trail work day at the new Horseshoe Bend Park 10/1/2011.

Ordinances/Resolutions

Supported Planning Board adoption of Riparian Zone Ordinance & Steep Slopes Ordinance (both adopted 4/7/2011).

Provided assistance and comments on drafts of the following (not adopted yet):

- Environmental Impact and Assessment/Threatened and Endangered Ordinance;
- Wind Energy Ordinance;

 Discussed development of driveway procedures (to avoid environmental problems associated with inappropriately sited driveways, e.g. In wetlands)

Anti-idling resolution adopted by Township Committee; wrote letter to Kingwood Twp School about anti-idling.

Completed 10 points of Stormwater education projects, as required by NJDEP.

Expanded information on Kingwood Twp website on recycling, native plants and rain gardens.

Community Day 9/17/11–information on NJWSA project, native species, arsenic in ground water, etc.

This consists of pre- and post- monitoring and assessments for stormwater control projects in a rural watershed, a statewide first-of-its-kind.
