<u>Carolyn Murphy, Advanced Animal Control – Discussion on Ordinance Requiring Rabies Vaccines for Cats</u>

Carolyn Murphy, Advanced Animal Control came to the Township Committee to talk about the importance of vaccination of rabies shots for cats in the township, especially with the many farms and barns in the area. She explained how serious the situation could be for those who have stray cats on their properties. Carolyn Murphy gave several examples of incidents she had regarding cats and rabies and talked about the risks. She also noted that there are several free rabies clinics in the County. She recommended the Township adopt an ordinance to require rabies shots for cats.

RESOLUTION OF THE TOWNSHIP OF KINGWOOD, COUNTY OF HUNTERDON, STATE OF NEW JERSEY GRANTING PRELIMINARY APPROVAL FOR THE PROPOSED ACQUISITION OF A DEVELOPMENT EASEMENT THROUGH THE MUNICIPAL/COUNTY PLANNING INCENTIVE GRANT PROGRAM ON THE STEM FARM, BLOCK 6, LOT 23.02

WHEREAS, the Township of Kingwood ("Township") has received an application for the sale of a Development Easement on Block 6, Lot 23.02 ("Property"), consisting of approximately 23.89^{+/}acres, owned by Gregory J and Jasmyn N. Stem ("Landowner"); and

WHEREAS, the Property is contained in Hunterdon County's Agriculture Development Area and is in Kingwood Township's Municipal and/or Hunterdon County's Planning Incentive Grant list of farms; and

WHEREAS, it is the Township's intent to submit the Property application to the State Agriculture Development Committee (SADC) pursuant to the State Agriculture Retention and Development Act, N.J.S.A. 4:lC-11 *et seq.*, the Planning Incentive Grant Program, N.J.S.A. 4:lC-43.1 *et seq.*, and the regulations thereunder; and

WHEREAS, the application contains (Schedule A – Project Map):

- a. One 2 acre non-severable exception limited to 1 single family residential unit(s) (subject to any and all approvals required by applicable law, ordinances, rules and regulations);
- b. No dwelling units on the easement area;
- c. No non-agricultural uses

WHEREAS, the Township supports the acquisition of a Development Easement on the Property for farmland preservation; and

WHEREAS, the Township is required to cover half of the local cost share on the purchase of the Development Easement; however, due to a shortage of available funds, this preliminary approval is conditioned upon an application being submitted by the Hunterdon Land Trust (HLT) or the SADC to the United States Department of Agriculture, Natural Resources Conservation Service (NRCS), Agriculture Conservation Easement Program (ACEP) for an Agricultural Land Easement (ALE) grant for an amount sufficient enough to cover the Township's cost share; and

WHEREAS, the Property and Landowner appear qualified for ALE grant funds; and

WHEREAS, the landowner has agreed to the additional restrictions associated with the ALE Grant, including no future division of the premises and a 5.33% maximum impervious coverage restriction (approximately 1.14 acres) for the construction of agricultural infrastructure on the Property outside of exception area, which is the maximum allowable for this property through the ALE program at this time; and

WHEREAS, the SADC's Municipal/County Planning Incentive Grant Program requires two independent appraisers to evaluate the land value of the property under current market conditions based on factors including, but not limited to local zoning, state regulations, wetlands, soils and septic suitability; and

WHEREAS, the SADC will approve a Certified Market Value of the Development Easement, which will then be the basis of the Township offer to the Landowner for the purchase of the Development Easement; and

WHEREAS, the Landowner has agreed to enter into an Appraisal Agreement with the Township wherein they will pay for half the cost of the appraisals, which will be reimbursed to them if they accept the Township's offer for the Development Easement and after the closing on the sale of the Development Easement with the County

WHEREAS, the SADC and County may reimburse the Township for up to 50% of the eligible ancillary costs for the purchase of a development easement; and

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of Kingwood as follows:

- 1. The WHEREAS paragraphs set forth above are incorporated herein by reference.
- 2. The Township is authorized to enter into an Appraisal Agreement with the Landowner
- 3. The Township is authorized to bid for and award appraisal services once the SADC has granted Green Light Approval, pursuant to N.J.A.C. 2:76-17A et seq., and the Landowner has entered into an Appraisal Agreement with the Township.
- 4. The Township will review the two independent appraisals and submit them to the SADC for a Certified Fair Market easement value of the Development Easement.
- 5. The Township's preliminary approval, acceptance of the application and participation in this acquisition is contingent upon approval and funding from the SADC, the NRCS, and/or the County of Hunterdon.
 - 6. A copy of this resolution shall be sent to the County of Hunterdon and the SADC.
