Kingwood Township Committee Minutes

March 3, 2022 - 7:00PM

A Regular Meeting of the Kingwood Township Committee was called to order at 7:00P.M. with Mayor Syrnick presiding.

Also present at the meeting were Deputy Mayor Ciacciarelli, Committee Member Andrew A. Russano, Attorney Katrina Campbell, C.F.O. Diane Laudenbach, Deputy Clerk Michele Tipton-Walters and Clerk Cynthia Keller. Mayor Syrnick called the meeting to order and following the salute to the flag, read aloud the following:

Adequate notice of this meeting was provided in accordance with the Open Public Meetings Act by publication of the notice in the Hunterdon Democrat and Courier News on January 6, 2022 and by telefaxing a copy of the notice to the Express Times on January 4, 2022. Copies of the notice were also posted in the Kingwood Township Municipal Building, Township Website and the Baptistown Post Office.

In order to ensure full public participation in this meeting, all members of this Committee, and also members of the public are requested to speak only when recognized by the Chair so that there is no simultaneous discussion or over-talk, and further, all persons are requested to utilize the microphones which are provided for your use by the Township. Your cooperation is appreciated.

Due to the continuing COVID19 precautions, the Township Committee meeting is a virtual meeting held on line. The meeting is hosted on Zoom and the link can be found on the Kingwood Township website Home Page under Current Agendas.

Roll Call

Public Comment - Privilege of the Floor

Mary MacConnell, Spring Hill Rd. – Asked to remove from the Consent Agenda - Resolution No. 2022 – 27 Approval of LOSAP List of Members for 2021, and that the list of members for 2021 and the amount of money that will be put towards each qualified individual for the LOSAP Program be read aloud.

Resolution No. 2022- 32 Public Hearing – Public Comments/Privilege of the Floor Limit of Time – Mary MacConnell requested this resolution be taken off the Consent Agenda and read aloud.

Resolution No. 2022 – 34 Appointment to the Emergency Management Council – Mary MacConnell requested this resolution be taken off the Consent Agenda and read aloud.

Mrs. MacConnell asked Committee Member Russano if he had any plans to take a newly elected official's course. Committee Member Russano responded and stated yes, he is signed up and will be attending the training.

<u>David Frank, Muddy Run Rd.</u> – Commended the Township Committee regarding the presentation they had last month regarding a cannabis business who was interested to build in Kingwood. The meeting was a good turnout, and he thanked the Township Committee for inviting the public to speak.

David Frank thanked Committee Member Russano for reaching out to the County Commissioners regarding the concerns of the bridge near his property.

Public Comment - Privilege of the Floor Continued

Mr. Frank questioned why the Township would consider two different attorneys for the Land Use Boards. Mayor Syrnick noted she has been in contact with the firm who will be taking over as the new attorneys. Mr. Michael O'Grodnick Esq. will be the Land Use Attorney for both Boards. Mayor Syrnick explained Mr. O'Grodnick has a conflict for the March 9th, Board of Adjustment meeting, therefore, Matthew Flynn from the firm sitting in for him.

Mr. Frank asked if the April 7, 2022 Township Committee meeting will be in person. Mayor Syrnick responded yes, the meeting will be in person and posted on the website.

<u>Lois Voronin, Union Rd.</u> – Noted reading prior minutes from the Township's website and asked a few questions regarding the Township's plans for the proposal for a new municipal building. Mayor Syrnick noted the Township looked into the cost to build a new municipal building approximately two years ago, due to the poor condition of the current building. It is not ADA compliant; it floods and needs a lot of repairs.

The Township Committee members at the time of that review were the following: Richard Dodds, Thomas Ciacciarelli and Maureen Syrnick, who decided not to build the new building at that time, as they felt it was too much money to spend. The Municipal Court system regulations are very strict, which made it is very expensive. Lois Voronin asked about the amount of money that was spent on the proposed plans two years ago and also asked if the Township decides to reconsider a new building in the future, will the Township make this public. Mayor Syrnick responded by stating, it may be 3, 5, or 10 years down the road before they consider it again. The plans which were designed two years ago are solid and they can be used in the future. At this time there are no plans to build a new municipal building.

<u>Richard Dodds, 56 Tumble Falls Rd</u> – Asked the Township Committee when they started allowing the use of electronic office equipment during work hours to employees who are employed by outside companies. Attorney K. Campbell stated this is a personnel issue and should not be discussed. She explained an allegation has been made and the Township will look into this further.

<u>Frank Floyd, EMC</u> – Thanked Deputy EMC, C. Keller for her assistance during the most recent storm with Township residents in need of help. Also contacting service providers to get assistance to restore issues that needed to be addressed. He feels that everything is coming together and the Emergency Management Council is working in the right direction.

John Mathieu – Asked the Township Committee what was the wrong direction, and what was the reason for letting the other person go. Mayor Syrnick stated his is a personnel issue and cannot be discussed at the meeting this evening. The Township is working to do the best for the Township and the residents and we are moving forward.

RECYCLING TONNAGE GRANT

WHEREAS, the recycling regulations impose on municipalities certain requirements as a condition for applying for tonnage grants, including, but not limited to, making and keeping accurate, verifiable records of materials collected and claimed by the municipality; and

WHEREAS, a resolution authorizing this municipality to apply for the 2021 Recycling Tonnage Grant will memorialize the commitment of this municipality to recycling and indicate the assent of the Kingwood Township Committee to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling regulations; and

WHEREAS, such a resolution should designate the individual authorized to ensure that the application is properly completed and timely filed; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Kingwood that the Township of Kingwood hereby endorses the submission of the Recycling Tonnage Grant application to the New Jersey Department of Environmental Protection and designates Michele Tipton-Walters to ensure that the said Application is properly filed; and

Mayor Syrnick reviewed the resolution. Mary MacConnell commented that there has never been a limit to public comments in all the years she worked for the Township. She suggested the Township consider changing the wording to this resolution. She feels there has never been a problem in the past. Attorney K. Campbell stated it was her recommendation to the Township Committee to adopt this resolution so there is a policy on the books.

<u>Karen Nuckols, State Hwy. Route 12</u> - Finds it unnecessary to have this resolution. She feels it will stifle the public. If there is a large turnout of people at a meeting where people want to be heard, then consider limiting each person to speak for that meeting only.

<u>John Mathieu</u>, <u>Federal Twist Road</u> – Feels this is not a good idea and all the people need to be heard. Feels that it is good public policy to let the public speak.

<u>Debbie Kratzer, Hill Road</u> – Agrees with Mary MacConnell, Karen Nuckols and John Mathieu. At the Penn East Pipeline meetings, she knows how it feels to be limited with time to speak. She feels if there is not enough time for everyone to speak, then the meetings should be continued on another date.

Lois Voronin, Union Road - Agrees with everyone that has spoken regarding this resolution.

Mayor Syrnick thanked everyone for their comments and would like to table this resolution at this time. Resolution No. 2022 - 32 was not adopted at the meeting this evening.

Resolution No. 2022-34 Appointment to the Emergency Management Council

This resolution was taken off the consent agenda for discussion. Resident Mary MacConnell, Spring Hill Road, requested this resolution be read aloud. Mayor Syrnick brought up the resolution document for everyone to review. Mary MacConnell thanked Mayor Syrnick for bringing up the resolution to see the members who were appointed for the Emergency Management Council for 2022.

John Mathieu, Federal Twist Road – Asked if anyone approached Jack MacConnell regarding his performance, actions and behavior regarding his position as Emergency Management Coordinator. He asked if anyone disciplined him for any action that they felt needed. Attorney K. Campbell recommended the Township Committee not answer these questions. She noted the term for this position expired and a new appointment was made.

ORDINANCE NO. 22-01-2022 CALENDAR YEAR 2022 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A:4-45.14) — Public Hearing and Final Adoption

Mayor Syrnick read aloud the ordinance by title, which was then introduced:

This Ordinance was introduced on first reading at a meeting of the Kingwood Township Committee on the 3rd day of February 2022.

The Ordinance was published in the Hunterdon County Democrat on February 10, 2022, and has been posted in the Kingwood Township Municipal Building on February 4, 2022. Copies of the Ordinance have been available for inspection by the public since February 4, 2022.

It was moved by Mr. Ciacciarelli, seconded by Mr. Russano and carried to open the public hearing. All voted Aye on Roll Call Vote.

Public Comments: John Mathieu, Federal Twist Rd – Asked for an explanation why this ordinance is being introduced. Attorney K. Campbell explained this ordinance is part of the budget and required to be adopted in case it is needed.

It was moved by Mr. Ciacciarelli, seconded by Mr. Russano and carried to close the public hearing. All voted Aye on Roll Call Vote.

ORDINANCE NO. 22 - 01- 2022

CALENDAR YEAR 2022 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A:4-45.14)

WHEREAS, the Local Government Cap Law, NJSA 40A:4-45.1 et seq., provides that in the preparation of its annual budget a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to three and one-half percent (3.5%) over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, NJSA 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the three and one-half (3.5%) percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Township Committee of the Township of Kingwood in the County of Hunterdon finds it advisable and necessary to increase its CY 2022 budget by up to three and one half percent (3.5%) over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Township Committee of the Township of Kingwood in the County of Hunterdon hereby determines that a three and one-half percent (3.5%) increase in the budget for said year, amounting to \$21,981.85 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Township Committee of the Township of Kingwood and County of Hunterdon hereby determines that any amount authorized hereinabove that is not appropriated, as part of the final budget, shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Kingwood, in the County of Hunterdon and State of New Jersey, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2022 budget year, the final appropriations of the Township of Kingwood shall, in accordance with the ordinance and NJSA 40A:4-45.14 be increased by 3.5%, amounting to \$76,936.48, and that the CY 2021 municipal budget for the Township of Kingwood be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within five (5) days of introduction; and

BE IT FURTHER ORDAINED that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within five (5) days after such adoption.

NOTICE is hereby given that the foregoing Ordinance was introduced to pass on first reading at a regular meeting of the Committee of the Township of Kingwood held on February 3, 2022 and ordered to be published in accordance with the law. Said Ordinance will be considered for final reading and adoption at a regular meeting of the Township Committee to be held on March 3, 2022, at 7:00 PM, or as soon thereafter as the Township Committee may hear this Ordinance at the Municipal Building, 599 Oak Grove Road, Frenchtown, New Jersey, at which time all persons interested may appear for or against the passage of said Ordinance.
