Kingwood Township Committee Minutes

August 4, 2022 – 7:00PM

A Regular Meeting of the Kingwood Township Committee was called to order at 7:00P.M. with Mayor Syrnick presiding. The Township Committee Meeting was in person on this date of August 4, 2022.

Also present at the meeting were Deputy Mayor Ciacciarelli, Committee Member Russano, Attorney J. Moscagiuri, C.F.O. D. Laudenbach, Deputy Clerk M. Tipton-Walters and Clerk C. Keller. Mayor Syrnick called the meeting to order and following the salute to the flag, read aloud the following:

Adequate notice of this meeting was provided in accordance with the Open Public Meetings Act by publication of the notice in the Hunterdon Democrat and Courier News on January 6, 2022 and by telefaxing a copy of the notice to the Express Times on January 4, 2022. Copies of the notice were also posted in the Kingwood Township Municipal Building, Township Website and the Baptistown Post Office.

In order to ensure full public participation in this meeting, all members of this Committee, and also members of the public are requested to speak only when recognized by the Chair so that there is no simultaneous discussion or over-talk, and further, all persons are requested to utilize the microphones which are provided for your use by the Township. Your cooperation is appreciated.

First Responders Monthly Reports

Committee Member Russano, introduced the following First Responders present:

Chief, Dwain Floyd, Kingwood Volunteer Fire Company

Dwain Floyd EMC, reported 19 calls, which most of them were in Kingwood Township for the month of July, including a couple vehicle accidents along Route 12. There was a bus fire from Big Bear Country, no injuries. Fire Marshall, Dennis Concannon was also present at the scene of the fire. Dwain Floyd noted it is working out well working with the Fire Marshall. He received confirmation from FEMA for the COVID grant.

The Fire Company will be on standby and prepared for Community Day on September 24, 2022 for the fireworks. They also plan to have a tent to give out information to educate the public.

EMC, Dwain Floyd – Reported for June 2022

Dwain Floyd noted he will have the County put up electronic signs at the end of Route 12/Route 519 and at the end of Union Road one week before Community Day. He has been busy working on the RPA's for Tropical Storm Ida. Unfortunately, the representative he was working with on FEMA is moving to a new position. Dwain Floyd is hoping to move forward working with a new person to get the grant funds.

100% of the repairs have been completed on Horseshoe Bend Road and Fairview Road. Dwain Floyd gave an estimated amount the Township will be reimbursed through grants. There will be a few roads, which will need to go out for bids.

There were a few power outages in the south area of the Township. JCP&L will be taking down several trees near Lockatong Road and they will be tree trimming in August. Also, in mid-August JCP&L will be flying over Kingwood in a helicopter doing air inspections. Mayor Syrnick reminded Dwain Floyd he has access to the Township's website to post emergency information for the public.

Chief, Kerry Floyd from Kingwood Twp. Rescue Squad

Chief Kerry Floyd was unable to attend the meeting, she was out on a call tonight.

Fire Marshall Dennis Concannon – Reported for Month of July 2022

Chief/Fire Marshall Dennis Concannon reported – A total of 33 inspections in Kingwood Township. (4) Non-Life Hazard Use Inspections, (8) Life Hazard Use Inspections, (9) Residential 1 & 2 Family Homes, (12) Re-Inspections and (0) Complaint/Spot/Other Inspections.

Chief Concannon will inspect the area at the Kingwood Park where the fireworks will take place and make the determination for Community Day scheduled on September 24, 2022.

Historian, Betty DeSapio, Stompf Tavern Road – Historical Society - Reported for month of July 2022

Historian Betty DeSapio reviewed her monthly report. She expressed her disappointment in the Township Committees decision on the William Lindsay White House. She is willing to help in any way she can. She is getting the word out for those interested to be involved in starting a committee to work on the historic preservation of the White House. She noted she would like to have a table at Community Day to set up information on the Historical Society.

Public Comment Privilege of the Floor

John Scricco, County Route 519 – Resident came to the Township Committee to discuss letters he received from the Township's Zoning Officer. He explained he bought the farm next door to his home and property. He has a farmstand to sell items to save the residents money. He is in contact with the County to register this property as a commercial farm. He and his wife counted 26 residents who are running businesses from Route 12 to Barbertown Point Breeze Road. He feels that he is being singled out. Their current farm stand has been closed for the past three weeks. They are producing 75% of what they are selling at his farmstand. Mr. Scricco spoke to Bob Hornby from Hunterdon County Agricultural Development Board. The shed where they sell items is not on his private property, but on his farmland piece of property. Mr. Scricco wanted to know who directed the Zoning Officer to send him this letter of violations.

Attorney James Moscagiuri explained what the Zoning Officer's position is in the Township and that he enforces the Township Ordinances. He explained the Zoning Officer is directed by the (DCA) Department of Community Affairs. The Attorney recommended Mr. Scricco come speak to the Township's Zoning Official to discuss the letter.

David Frank, Muddy Run Road – Resident came to find out an update from the County regarding the Muddy Run Road study. Committee Member Russano responded the County Engineer has been working with the County and they have agreed to fund the project, but he does not know when. Mayor Syrnick will reach out and speak to the Zoning Officer to get an update.

Jamie Sackie, Edison NJ – Attended the meeting to discuss the restoration of the Lindsay White House resolution. She asked the Township Committee if they officially rejected the grant of \$250,000 and to also make the William Lindsay White House a Historical building. Mayor Syrnick responded, yes they did at this time. She explained the Township is working to restore the William Lindsay White House to make it a safe structure so it can be open to the public. Mayor Syrnick explained the large amount of funds it would cost to restore the White House, which was presented by a spreadsheet in detail and discussed at the Special Township meeting on July 19, 2022.

Jamie's Sackie noted her father replaced the roof on the White House years ago and that it should last at least another 10 years. She asked who will oversee this project to restore the building, is there a committee established, and how long it will take to open the building. Mayor Syrnick explained some of the repairs that will need to be done. Also, the Construction Official will be inspecting to make sure it is restored safe and properly. Jamie Sackie stated her father is willing to help out in anyway.

Jenna Kimuck, Flemington, NJ - Asked several questions regarding forming a historical Committee to work on this project. Mayor Syrnick explained Historian Betty DeSapio would be the person to speak to for volunteering. Volunteers are welcome to persons who are a resident of the Township. Jenna asked several questions regarding the historical value of the home.

Mary MacConnell, Spring Hill Road – Asked if the Environmental Commission's Annual Newsletter and Report for 2021 will be on the website. Mayor Syrnick stated the newsletter and report is currently on the Township's website under Boards and Committees/Environmental Commission. M. MacConnell also requested that the resolution which is up for adoption this evening regarding the William Lindsay White House be brought up and read out loud to the public. She requested the letter under New Business, a letter of resignation and retirement from the Township Clerk be brought up on the overhead screen and read loud.

Attorney James Moscagiuri responded by stating the letter from the Township Clerk is considered personnel and should be discussed under executive session. Since it has to do with personnel, it should not be public information at this time. The letter will be discussed under Executive Session.

Lois Voronin, Union Road – Thanked the Township for having a resolution to maintain and restore the William Lindsay White House. She would like to know the estimated time to start the restoring project for the White House, as it is not mentioned in the resolution. L. Voronin would like to volunteer in the preparation of the restoration. C.F.O. Diane Laudenbach explained what the process would be which the Township would need to do before working on the house.

RESOLUTION NO. 2022 – 90

STIGMA FREE COMMUNITIES' RESOLUTION

WHEREAS, it is widely recognized that mental health issues are at the core of the numerous violent events around the nation, where so many have been randomly killed, wounded, or traumatized and that one of the key factors in preventing violent actions from occurring in the first place is to provide greater access to mental health services that includes breaching the barrier of the stigma associated with mental illness; and

WHEREAS, while a very small percentage of those in need of mental health care will ever turn violent, the stigma associated with the disease of mental illness is identified as the primary reason individuals fail to seek the help they need to recover from the disease; and

WHEREAS, Stigma-Free Communities aim to inspire public interest and open dialogues about stigma, raise awareness of the disease of mental illness, and create a culture wherein residents who have the disease of mental illness feel supported by their community and Neighbors, and feel free to seek treatment for the disease without fear of feelings of shame or disgrace, being stigmatized; and

WHEREAS, the Township Committee of the Township of Kingwood wishes to lead our community in recognizing the need to eliminate the stigmatization of mental illness by designating Kingwood Township as a Stigma Free community, promoting awareness that there can be no "health" without mental health, breaking down barriers, and encouraging residents of all ages to be mindful of their mental health and to ask for help when needed, so recovery can begin, hope is inspired, and tragedies are avoided.

NOW, THEREFORE BE IT RESOLVED that the Township Committee of the Township of Kingwood hereby designates Kingwood Township as a Stigma-Free Community, raising awareness of the resources available and encouraging those who may have identified, and for all residents to demonstrate compassion, understanding, and support through the elimination of the stigma towards those living with mental illness.

BE IT FURTHER RESOLVED that the Township of Kingwood joins with Hunterdon County and many of the communities in the county in becoming Stigma Free By 2023.

WHEREAS, a number of local units have joined together to form the Statewide Insurance Fund ("FUND"), a joint insurance fund, as permitted by N.J.S.A. 40A:10-36, *et seq.*; and

WHEREAS, Township of Kingwood has complied with relevant law with regard to the acquisition of insurance; and

WHEREAS, the statutes and regulations governing the creation and operation of joint insurance funds contain elaborate restrictions and safeguards concerning the safe and efficient administration of such funds; and

WHEREAS, the Township of Kingwood (the LOCAL UNIT) has determined that membership in the FUND is in the best interest of the LOCAL UNIT.

WHEREAS, the LOCAL UNIT agrees to be a member of the FUND for a period of three (3) years, effective from **January 1, 2023** terminating on **January 1, 2026** at 12:01 a.m. standard time; and

WHEREAS, the LOCAL UNIT has never defaulted on claims, if self-insured, and has not been canceled for non-payment of insurance premiums for two (2) years prior to the date of this Resolution; and

NOW, THEREFORE, BE IT RESOLVED that the LOCAL UNIT does hereby agree to join the Statewide Insurance Fund; and

BE IT FURTHER RESOLVED that to the extent required by law, the Local Unit shall provide notice of the Indemnity and Trust Agreement to the Office of the State Comptroller; and

BE IT FURTHER RESOLVED that the LOCAL UNIT will be afforded the following coverage(s):

Keller is hereby the LOCAL UNIT's Fund Commissioner is authorized and directed to execute the Indemnity and Trust Agreement and such other documents signifying the membership in the FUND as required by the FUND's Bylaws and to deliver same to the Administrator of the FUND with the express reservation that said documents shall become effective only upon the LOCAL UNIT's admissions to the FUND following approval of the FUND by the New Jersey Department of Banking and Insurance.

Resolution No. 2022-92 Statewide Ins. Fund Indemnity and Trust Agreement

RESOLUTION NO. 2022 - 92

STATEWIDE INSURANCE FUND

INDEMNITY AND TRUST AGREEMENT

THIS AGREEMENT made this 4th day of August 2022, in the County of Hunterdon, State of New Jersey, by and between the Statewide Insurance Fund (hereinafter "FUND"), and Township of Kingwood in the County of Hunterdon, a duly constituted local unit of government (hereinafter "LOCAL UNIT");

WHEREAS, two or more local units have collectively formed a joint insurance fund as such an entity is authorized and described in N.J.S.A. 40A:10-36 et seq.; and

WHEREAS, the LOCAL UNIT has agreed to become a member of the FUND in accordance with and to the extent provided for in the Bylaws of the FUND and in consideration of such obligations and benefits to be shared by the membership of the FUND; and

WHEREAS, the LOCAL UNIT has complied with relevant law with regard to the acquisition of insurance;

NOW, THEREFORE, it is agreed as follows:

1. The LOCAL UNIT, upon entering the FUND, agrees to be bound by and to accept and comply with each and every provision of the FUND's Bylaws, Risk Management Program, as it applies to the LOCAL UNIT and the applicable statutes and administrative regulations pertaining to joint insurance funds.

2. The LOCAL UNIT agrees to participate in the FUND with respect to those coverage listed in the LOCAL UNIT's "Resolution to Join" in accordance with the FUND's Bylaws and Risk Management Program.
3. The LOCAL UNIT agrees to become a member of the FUND until **January 1, 2026**, at 12:01 a. m. eastern standard time. The commencement date shall be the effective date as established by the FUND's Bylaws and policies.
4. The LOCAL UNIT certifies that it has not been canceled for non-payment of insurance premiums for a period of at least two (2) years prior to the date hereof, or, if self-insured, that it has never defaulted on any claims.
5. In consideration of membership in the FUND, the LOCAL UNIT agrees that it shall jointly and severally assume and discharge the liability of each and every member of the FUND in accordance with statute and regulation, and by execution hereof the full faith and credit of the LOCAL UNIT is pledged to the punctual payment of any sums which shall become due to the FUND in accordance with the Bylaws thereof, this Agreement or any applicable statute or regulation.
6. If the FUND, in the enforcement of any part of this Agreement, shall incur necessary expense or become obligated to pay attorney's fees and/or court costs, the LOCAL UNIT agrees to reimburse the FUND for all such reasonable expenses, fees and costs on demand.
7. The LOCAL UNIT and the FUND agree that the FUND shall hold in trust all monies paid by the LOCAL UNIT to the FUND and those monies will be used in accordance with all applicable statutes, the FUND's Bylaws and the Risk Management Program.
8. If required by the Commissioner of Insurance or applicable statutes or regulations, the FUND shall establish separate trust fund accounts in accordance with N.J.S.A. 40A:10-36, et seq. and any other statutes or regulations that may be applicable. Said trust accounts shall be used solely for the payment of claims made against members of the FUND, excess insurance premiums and/or the administration of the FUND, or for such other purposes as now or hereunder permitted by statute or regulation.
9. Each LOCAL UNIT which shall become a member of the FUND shall be obligated to execute an agreement similar in form to this Agreement.
10. To the extent required by law, the LOCAL UNIT shall provide notice of this Agreement to the Office of the State Comptroller.

Resolution No. 2022-93 Reserve for Preliminary Expenses – Hammer Road

WHEREAS, N.J.S.A. 54:4-66.3(d) requires that at least 25 days elapse between the time tax bills are mailed to the date taxes are due; and

WHEREAS, it is the desire of the Mayor and Township Committee of the Township of Kingwood to allow sufficient time for preparation and mailing of the 2022/2023 tax bills after the rate has been struck and for compliance with the statute first above cited.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Committee of the Township of Kingwood, County of Hunterdon and State of New Jersey, that the grace period for the payment of the 3rd quarter 2022 property tax installment is extended to August 31, 2022 and any tax payments received after August 31, 2022, interest will be assessed from August 1, 2022.

Resolution No. 2022-96 Supporting Passage of Senate Bill No. 713 to Commemorate the Events of Sept 11, 2001

RESOLUTION NO. 2022 – 96

**SUPPORTING PASSAGE OF SENATE BILL NO. 713
TO COMMEMORATE THE EVENTS OF SEPTEMBER 11, 2001**

WHEREAS, The New Jersey State Senate recently passed Senate Bill No. 713, which would require school districts to include information on events of September 11, 2001, as part of New Jersey Student Learning Standards in Social Studies and requiring public schools to hold annual events commemorating September 11, 2001;

WHEREAS, Commemorating September 11th annually allows families and friends to honor and remember the legacy of their loved ones whose lives were lost to the deadly terrorist attacks that day; and

WHEREAS, Including curriculum on September 11th as part of the regular public-school instruction will provide students with information on the historical context of the attack, a timeline of the day as events unfolded, the heroic actions of first responders that day and the immediate days that followed, the global response to the events of 9-1-1, and strategies for teaching tolerance, acceptance and embracing of people of different religions and cultures;

WHEREAS, This legislation is needed so ensure that future generations do not only forget about the tragedy of September 11, 2001 but also to know that the United States and many nations rose up against this terrible act of international terrorism and reaffirmed a global commitment to freedom;

NOW, THEREFORE, BE IT RESOLVED, that the Township of Kingwood extends its support of Senate Bill No. 713 as we approach the 21st anniversary of September 11th; and

BE IT FURTHER RESOLVED, that the Township of Kingwood calls upon the New Jersey Legislature to pass this legislation and for Governor Murphy to sign this bill into law so that future generations never forget the events of September 11, 2001.

Resolution No. 2022-95 Maintaining the William Lindsay White House for Future Historic Preservation

Mayor Syrnick introduced and read the following Resolution for the public:

RESOLUTION NO. 2022 - 95

**RESOLUTION TO PROTECT AND MAINTAIN THE WILLIAM LINDSAY WHITE HOUSE
AND TO RE-EXAMINE THE APPLICATION FOR
FULL HISTORIC RESTORATION IN
FIVE YEARS**

WHEREAS, Kingwood Township is the owner of the William Lindsey White House and surrounding farm & forest lands, purchased using New Jersey State Green Acres funds. Kingwood Township has an obligation to maintain and protect the William Lindsey White House and provide public access to the property and house; and

WHEREAS, through several grants, Kingwood Township, in 2020 developed a plan for historic restoration with an application to the New Jersey Historic Trust Fund for a construction grant to begin historic restoration of the William Lindsey White house. This application provides a detailed documentation of what repairs and replacements are needed for historic restoration and preservation; and

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Kingwood, County of Hunterdon, State of New Jersey as follows:

1. Kingwood Township will endeavor to provide regular maintenance and repairs to the house structure with care, and intent to do no harm to the historic value of the house and property, using the plan and application for historic restoration of the William Lindsey White House, written in 2020, as a guide.
2. Kingwood Township will endeavor to begin the maintenance process by utilizing the \$45,000 grant from Hunterdon County to begin to waterproof the basement and construct a vegetated swale to divert ground water around the house. In addition to the County grant, Kingwood Township will utilize additional funds of up to \$50,000 from the Kingwood Township Open Space Trust Fund, to repair and/or stabilize the floor joists, repair windows, and repair and paint any damaged wood on the house exterior.
3. In addition to the Grant and Trust Fund monies, Kingwood Township will utilize all programs offered by the County and State to further paint or repair the structure.
4. In addition to repair work to waterproof and stabilize the house's condition, Kingwood Township will ask volunteers and groups interested in the preservation of this property, to assist in cleaning the interior of the building with the intent to re-open the building to the public.
5. Kingwood Township's current intent is to make the building a place to hold meetings, and allow the public to see the house, for the purpose of educating the public of the historic importance of the house and property, and garner public support of a full restoration of the house.

6. Kingwood Township will also ask volunteers and groups interested in preservation of this property to assist the Township by garnering public support for this preservation project through public outreach.
7. Kingwood Township's intention is that Township Committee, Parks and Recreation Committee, and the Historical Society, will re-examine the preservation plans, as well as the grant opportunities available from the County, State and Federal Government for funding a historic renovation, and re-apply to add the property to the State and Federal historic property lists in or around 2027, when the debt service for the Horseshoe Bend property has been fully paid.




