THE PROPOSED ACQUISITION OF A DEVELOPMENT EASEMENT THROUGH  
THE COUNTY PLANNING INCENTIVE GRANT PROGRAM ON THE DAVID  
BARNES AND MAIA BARNES FARM, BLOCK 6, LOT 23.02 IN KINGWOOD  
TOWNSHIP**

**WHEREAS**, on September 22, 2022, the New Jersey State Agriculture Development Committee (SADC) certified a market value (CMV) of \$5,000 per acre for a Development Easement on property in the Township of Kingwood ("Township") known as Block 6, Lot 23.02. Consisting of approximately 23.8 acres owned by David Barnes and Maia Barnes, the farm is contained in Hunterdon County's County Planning Incentive Grant list of target farms and for which the Property Owners made an individual application pursuant to the State Agriculture Retention and Development Act, N.J.S.A. 4:1C-1 I *et seq.*, the Planning Incentive Grant Programs NJ-S.A. 4:1C-43.1 *et seq.*, and the regulations thereunder; and

**WHEREAS**, the application provided for the proposed acquisition of a Development Easement on the aforesaid Block 6 Lot 23.02 of approximately 23.8 acres; and

**WHEREAS**, the property's application includes: zero Residential Dwelling Site Opportunity (RDSO); zero existing dwellings in the Proposed Easement Area; zero severable exceptions; and one 3.8-acre non-severable exception for one existing single-family residential unit and future flexibility; resulting in approximately 20.0 preserved acres; and

**WHEREAS**, on October 19, 2022, the landowners accepted the offer of \$5,000.00 per acre, conditioned upon all interested parties granting final approval for acquisition of a development easement; and providing for a commitment of funding pursuant to N.J.A.C 2:76-17.16; and

**WHEREAS**, the Hunterdon Land Trust will submit a parcel application to the United States Department of Agriculture, Natural Resources Conservation Service (NRCS) Agriculture Conservation Easement Program (ACEP) for an Agricultural Land Easement (ALE) grant; and

**WHEREAS**, the landowner has agreed to the additional restrictions associated with the ALE Grant, restricting the farm from any future division and requiring a 5.33% maximum impervious coverage restriction (approximately 1.06 acres) for the construction of agricultural infrastructure on the Property outside of the exception area, which is the maximum allowable for this property through the ALE program at this time; and

**WHEREAS**, the estimated cost sharing breakdown for the acquisition of the development easement is as follows (based on an estimated 20 net acres), subject to the actual acreage to be covered by the Development Easement per the final survey which conforms to the farmland preservation program requirements, and any additional adjustments pursuant to State statute, rule, regulation or policy;

1. The Township Committee gives final approval to the proposed acquisition of a Development Easement to be held by Hunterdon County on the David Barnes and Maia Barnes Farm, Block 6, Lot 23.02 in the Township of Kingwood, County of Hunterdon, State of New Jersey, on approximately 23.8 acres pursuant to the County Planning Incentive grant program and application made by the Property Owners subject to the following conditions of conveyance of the easement.

The Township's final approval, acceptance of the application, and participation in this acquisition is contingent upon approval and acceptance of the State Agriculture Development Committee and receipt of federal grant funds to provide for the Township's proportionate cost share of the value of the development easement.

**RESOLUTION NO. 2022 – 140**

**RESOLUTION OF THE TOWNSHIP OF KINGWOOD, COUNTY OF HUNTERDON, STATE OF NEW JERSEY OPPOSING THE PROPOSED INCREASES TO THE STATE HEALTH BENEFITS PROGRAM**

**WHEREAS**, the State Health Benefits Program (SHBP), governed by N.J.S.A. 52:14-17.25 et seq., offers medical, prescription drug, and dental coverage to qualified State and participating local government public employees, retirees, and eligible dependents; and

**WHEREAS**, all SHBP plans are self-funded meaning that the money paid out for benefits comes directly from a SHBP fund supplied by the State, participating local employers, and member premiums; and

**WHEREAS**, the Division of Pensions and Benefits is responsible for the daily administrative activities of the SHPB, the State Health Benefits Commission is the executive organization responsible for overseeing the SHBP; and

**WHEREAS**, the State Health Benefits Commission, comprised of state officials and union representatives, annually consider the calendar year premium levels for the Local Government Employer Group of the SHBP based on recommendations found in the Rate Setting Recommendation Analysis of the Local Government Employee Group; and

**WHEREAS**, the preliminary rate increase for the 2023 Local Government Employer Group is 22.8%, which includes a 21.6% increase for Active, a 13% increase in Early Retiree, and a 0.7% increase for Medicare Retiree; and

**WHEREAS**, subsequent news accounts has Department of Treasury noting "rates for active members and early retirees would likely be increase between 12-20% across the various plans for the upcoming year"; and

**WHEREAS**, such proposed exorbitant rate increases will fall upon the local property taxpayer along with the local public employees at a time where there is record inflation, and

**WHEREAS**, the proposed premium increase for most active employees will take thousands more out of their paychecks annually and lead to huge costs for local governments that will translate into higher property tax bills for struggling families; and

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Kingwood in the county of Hunterdon call up the State Health Benefit Commission to reconsider the rate increase and strike a rate increase that is appropriate in the current economic conditions; and

**BE IT FURTHER RESOVLED**, that the governing body of the Township of Kingwood in the County of Hunterdon urge the legislature to adopt legislation expanding the composition of the State Health Benefits Commission to include representatives from both municipal and county government management; and

**BE IT FURTHER RESOLVED**, that a copy of this resolution be forwarded to Governor Murphy, State Treasurer Muoio, Senate President Scutari, Assembly Speaker Coughlin, State Senator Michael Doherty, Assemblyman Erik J. Peterson Assemblyman John DiMaio, and New Jersey State League of Municipalities.

**RESOLUTION NO. 2022 – 141**

**RESOLUTION OF THE TOWNSHIP OF KINGWOOD, COUNTY OF HUNTERDON,**

**STATE OF NEW JERSEY OPPOSITION TO THE REASSIGNMENT BY THE NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION OF ALL MUNICIPALITIES CURRENTLY DESIGNATED TIER B UNDER THE MUNICIPAL SEPARATE STORM SEWER SYSTEM PERMIT PROGRAM TO TIER A DESIGNATION AND EXPANSION OF TIER A PERMIT CONDITIONS**

**WHEREAS**, the New Jersey Department of Environmental Protection (NJDEP) has undertaken efforts to reassign to ‘Tier A’ designation under the Municipal Separate Storm Sewer System Permit program (MS4 Permit Program) all New Jersey municipalities currently designated ‘Tier B’; and

**WHEREAS**, compliance with the MS4 Permit Program for a municipality designated Tier A is far costlier and more onerous than compliance for a municipality designated Tier B; and

**WHEREAS**, under the existing designation system, the Tier B designation was specifically created for municipalities that are located in more rural areas and non-coastal regions, while Tier A designation was created for municipalities that are located within the more densely populated regions of the state or along or near the coast; and

**WHEREAS**, many municipalities designated Tier B under the existing designation system simply do not have the resources to comply with Tier A designation; and

**WHEREAS**, the NJDEP, while attempting to reassign all municipalities to Tier A, is simultaneously proposing to renew the Tier A MS4 General Permit to include additional conditions on municipal permit holders; and

**WHEREAS**, the NJDEP is asking current Tier B municipalities to come into compliance with both existing Tier A requirements and a set of still-unfinalized Tier A renewal requirements on practically the same schedule as existing Tier A municipalities; and

**WHEREAS**, the State, however well-intended in its actions, continues to saddle municipalities with additional responsibilities through unfunded and underfunded mandates, putting additional burdens on property taxpayers; and

**WHEREAS**, the reassignment by the NJDEP to Tier A designation for all New Jersey municipalities currently designated Tier B will result in a redistribution of these municipalities’ limited resources, away from their crucial government functions; and

**WHEREAS**, Kingwood Township supports taking action to better protect and improve the quality of its own waterways, as well as waterways throughout the State but efforts to do so must be balanced against other critical needs with consideration for the limit resources of municipal government.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township of Kingwood, in the County of Hunterdon, and the State of New Jersey as follows:

1. The Township of Kingwood hereby urges the members of the New Jersey Assembly and Senate to support, co-sponsor, and adopt legislation that would prevent the NJDEP from reassigning to Tier A designation under the MS4 permit program New Jersey Municipalities that are currently designated Tier B, and also prevent the NJDEP from expanding conditions of the Tier A permit until a full analysis of the fiscal impact these changes will have on these municipalities can be completed, and state funding is made available.
2. The Township of Kingwood hereby urges the Governor of State of New Jersey to sign any legislation adopted by the State Assembly and Senate which would prevent the NJDEP from reassigning to Tier A designation under the MS4 permit program New Jersey Municipalities that are currently designated Tier B, and also prevent the NJDEP from expanding conditions of the Tier A permit until a full analysis of the fiscal impact these changes will have on these municipalities can be completed, and state funding is made available..
3. Mayor Synchron read Ordinance 22-12-2022 by title.

**ORDINANCE NO. 22-12-2022**

**ORDINANCE OF THE TOWNSHIP OF KINGWOOD, COUNTY OF HUNTERDON, STATE OF NEW JERSEY CREATING CHAPTER 67 ENTITLED “BUSINESS REGISTRY” ESTABLISHING A REGISTRY FOR BUSINESS-, RENTAL- UNIT, AND MULTI-FAMILY HOMEOWNERS INSURANCE CERTIFICATES**

**WHEREAS**, the State of New Jersey has enacted a new statute which requires business owners, rental unit owners, and owners of multifamily homes which is four or fewer units, one of which is owner-occupied, to maintain certain liability insurance policies and register certificates of insurance demonstrating compliance with such statute with the municipality; and

**WHEREAS**, the requirement to register a certificate of insurance shall be effective as of November 6, 2022, 90 days following enactment; and

**WHEREAS**, said law provides that the municipality may, by ordinance, establish a reasonable administrative fee for the certificate of registration.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Kingwood, County of Hunterdon, State of New Jersey, as follows:

## **SECTION I**

### **Chapter 67 – Business Registry**

#### **§ 67-1. Liability Insurance Requirements.**

Pursuant to S.B. 1368, codified under N.J.S.A. 40A:10A-1 and -2, the owner of a business or owner of a rental unit(s) shall maintain liability insurance for negligent acts and omissions in an amount of no less than five hundred thousand dollars (\$500,000.00) for combined property damage and bodily injury to or death of one or more persons in any one accident or occurrence.

The owner of a multifamily home which is four or fewer units, one of which is owner-occupied, shall maintain liability insurance for negligent acts and omissions in an amount of no less than three hundred thousand dollars (\$300,000.00) for combined property damage and bodily injury to or death of one or more persons in any one accident or occurrence.

#### **§ 67-2. Registration Requirements.**

All business owners, rental unit owners, and owners of multi-family homes of four or fewer units, one of which is owner occupied, shall register a certificate of insurance as required by the aforementioned statute in the office of the Township Clerk on an annual basis, which office shall maintain a registry of certificates of insurance filed with it, and each registration shall be accompanied by payment of \$\_\_\_\_\_ as an administrative fee for such registration payable to the Township of Kingwood.

#### **§ 67-3. Failure to Register.**

The governing body is authorized to collect, through a summary proceeding pursuant to the “Penalty Enforcement Law of 1999,” P.L. 1999, C. 274 (C.2A:58-10 et seq.), a fine of not less than five hundred dollars (\$500.00) but no more than five thousand dollars (\$5,000.00) against an owner who failed to comply with the provisions of this Ordinance.

## **SECTION II**

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

### **SECTION III**

If any article, section, subsection, paragraphs, phrase or sentence is, for any reason, inconsistent with the Code of the Township of Kingwood, or is held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

### **SECTION IV**

This Ordinance shall take effect immediately upon final passage and publication as provided by law.

A motion by Russano, seconded by Syrnick to open public comment on Ordinance 22-12-2022 was unanimously approved by voice vote.

Committeeman Russano reported that Community Day in September was the first one in over three years and surpassed all expectations. Committeeman Russano stated that it was widely attended by the residents and that Parks and Recreation had agreed to host another Community Day in 2024.

Committeeman Russano noted that the Parks and Recreation Committee submitted a request to the Township Committee to continue the hunting program for the 2023-2024 hunting season. Committeeman Russano stated that this was addressed in Resolution #2022-124.

Committeeman Russano stated that a Parks and Recreation subcommittee had been formed to assist with the needs and future of the Lindsay White House. Committeeman Russano noted that the first meeting for this subcommittee would be November 21<sup>st</sup>.

Mayor Syrnick reported that the Environmental Committee is reviewing their by-laws and discussing how to best address the invasive species on Township properties. Mayor Syrnick stated that the Environmental Committee continues to work hard on tree planting in the riparian buffer zones.

Mayor Syrnick noted the Planning Board continues to discuss zoning along the Route 12 corridor.

- **Shared Services Agreement for Software for 2022-2023 with Delaware Valley Regional High School District Board of Education:** A motion by Russano, seconded by Syrnick was unanimously approved by roll call vote to approve the shared services agreement for software for 2022-2023 with the Delaware Valley Regional High School District Board of Education.
- **Leaking Basement Door at Municipal Building:** Mayor Syrnick noted that the main entrance to the Municipal Building is an internal door, which is causing an issue with leaks. Mayor Syrnick advised she would speak with the Department of Public Works to price out a proper external door.
- **Best Practices Checklist:** CFO Laudenbach explained that the checklist was almost complete with the exception of one question. The Committee reviewed and acknowledged the Best Practices Checklist. A motion by Russano, seconded by Syrnick to move forward with the Best Practices Checklist and accept it as is was unanimously approved by voice vote.
- **Recognition of Citizen with Outstanding Volunteerism:** Tabled for a future date.
- **Quote from Foveonics to Scan Files into the Electronic System:** Tabled until January 2023
- **Discussion on a Potential Letter from the Mayor to the State Official Regarding the Burden of the SHBP Costs to the Township:** Mayor Syrnick reported that she would draft a letter to State officials opposing the burden of the increased State Health Benefits Program cost that will be placed on the municipalities.
