

KINGWOOD TOWNSHIP COMMITTEE REGULAR MEETING MINUTES December 1, 2022 – 7:00 P.M.

Mayor Maureen Syrnick called the regular meeting of the Kingwood Township Committee to order on December 1, 2022 at 7:00 P.M. Mayor Syrnick announced that this meeting is called pursuant to the provisions of the Open Public Meetings Act. Notice of this meeting was faxed to the Hunterdon County Democrat and Courier News on January 6, 2022 and The Express Times on January 4, 2022, was posted on the bulletin board in the Municipal Building, Township Website, the Baptistown Post Office and filed with the Township Clerk on January 11, 2022.

PLEDGE OF ALLEGIANCE

Mayor Syrnick led those in attendance in the pledge to the nation's flag.

APPOINTMENT

A motion by Russano, seconded by Syrnick to appoint Republican Lance Riggio to fill the vacancy of committee member on the Township Committee was unanimously approved by roll call vote. Russano: Yes; Syrnick: Yes

MESSAGE FROM MAYOR

Mayor Syrnick addressed the power outages within the Township, Mayor Syrnick stated that OEM and JCP&L have treated all the incidents within the Township as if they were escalated to a BPU complaint and are working on the overwhelming amount of dead Ash trees, of which 430 trees have been removed to date. Mayor Syrnick noted OEM is working with JCP&L on gathering data regarding the cause of all incidents within the year for the Township.

RESOLUTION NO. 2022 – 147

IN SUPPORT OF TOWNSHIP OF KINGWOOD TO PARTICIPATE IN THE PLANNING INCENTIVE GRANT PROGRAM FOR 2023

WHEREAS, Kingwood Township has an established Municipal PIG program; and

WHEREAS, the Township has successfully preserved numerous farms within the Municipal PIG; and

WHEREAS, the Township wishes to expand the opportunity for preservation to additional farms in the Township; and

WHEREAS, the Township will pursue these opportunities as the landowners indicate interest in preservation and as the Township has or can acquire funding to complete preservation projects.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Kingwood, County of Hunterdon and State of New Jersey that Kingwood Township is in support of the Township participating in the (PIG) Planning Incentive Grant Program for 2023.

RESOLUTION NO. 2022 – 149

Correcting Tax Assessment and Real Estate Tax Due For Block 12, Lot 31 and Issuing Tax Adjustment

WHEREAS, Block 12, Lot 31 (the Property"), consists of land with certain improvements located thereon; and

WHEREAS, the Township's former Tax Assessor mistakenly indicated that the Property contained additional/other improvements than actually existed, thereby causing him to incorrectly establish the assessed value at \$395,600; and

WHEREAS, because of the error the real estate taxes due from the owners of the Property incorrectly totaled \$9,858.35; and

WHEREAS, the correct assessed value of the Property in its accurate condition for the year 2022 is \$233,000; and

WHEREAS, the correct amount of real estate tax due for the Property in its accurate condition total \$5,806.36; and

WHEREAS, the Township wishes to correct the tax assessment and cancel the excess real estate taxes resulting from said incorrect tax assessment.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Kingwood, in the County of Hunterdon, State of New Jersey, hereby authorizes and requests that the Township Tax Assessor and Township Tax Collector adjust the tax account of Block 12, Lot 31 to reflect:

- 1. The tax assessed value of the Property for tax year 2022 at \$233,000; and
- 2. The correct amount of real estate tax due for the Property for tax year 2022 at \$5,806.36

BE IT FURTHER RESOLVED, as follows:

- 1. A credit of \$2,026.00 shall be applied to the 3rd quarter of 2022
- 2. A credit of \$2,025.99 shall be applied to the 4th quarter of 2022
- 3. A credit of \$1,451.59 shall be applied to the 1st quarter of 2023

- 4. A credit of \$1,451.59 shall be applied to the 2nd quarter of 2023
- 5. That the Township Tax Collector is authorized to waive any interest and/or penalties that may have accrued because of the error referenced hereinabove

NEW BUSINESS

• Township Committee Liaison Reports: Committeeman Russano introduced OEM Coordinator D. Frank Floyd who reported on FEMA projects, a grant for a siren at the fire department, and ongoing power outage issues due to dead trees that need to be addressed by State DOT and residents as well as JCP&L.

Chief Kerry Floyd of the Kingwood Township Rescue Squad reported on the rescue squads' responses within the Township as well as any mutual aid. Chief Floyd also noted on the rise in viruses in the area.

Committeeman Russano noted that the Parks and Recreation Committee member T. Jordan was stepping down and expressed gratitude for his volunteerism.

Committeeman Russano stated that the Parks and Recreation subcommittee for the Lindsay White House met on November 21st and has a preliminary plan to move forward.

Committeeman Russano the Tree Lighting would be at 4 p.m. on December 3rd at the Union Road Park.

Committeeman Russano noted there are concerns of speeding drivers. Committeeman Russano stated the speed indicator has been inspected and will be placed on problem roads within the Township. Committeeman Russano also noted it the data received will be sent to the NJSP and DPW.

Committeeman Russano stated the following events would be occurring at the school – 12/9 Senior Breakfast 12/11 Breakfast with Santa at the Kingwood Volunteer Fire Department, 12/12 Winter Concert. Committeeman Russano stated the Board of Education would be hiring a security consultant to draft a plan of action for a potential class II officer. Committeeman reported the Board of Education is working on a grant to help students with learning loss and ways they can improve their education after the COVID-19 pandemic.

Fire Marshall Dennis Concannon reported on the Fire Safety Report for the month of November.

Mayor Syrnick stated the Planning Board is improving and amending an ordinance on the Scenic Overlay to have it be easier to understand.

Mayor Syrnick reported the Environmental Commission removal of trees and invasive species is down at this time due to the time change and colder temperatures. Mayor Syrnick also noted the Environmental Commission is looking to update the Environmental Assessment Plan.

Mayor Syrnick noted no updates for Open Space / Agricultural Advisory Committees.

- **Set Date for End of Year Township Committee Meeting:** The Committee decided on a date of December 28th via Zoom only at 2 p.m.
- Appointment of Insurance Fund Members to Replace C. Keller and T. Ciacciarelli: Mayor Syrnick noted that there are two vacancies which are filled by the Clerk and a

Township Elected Official on the Insurance Fund Committee. The committee discussed and agreed T. Crivelli and M. Syrnick would fill the vacancies.

A motion by Riggio, seconded by Russano to have T. Crivelli and M. Syrnick fill the vacancies on the Insurance Fund Committee was unanimously approved by roll call vote. *Riggio: Yes; Russano: Yes; Syrnick: Yes*

- Acknowledge Resignation of T. Jordan as a Member of the Parks and Recreation Committee: A motion by Russano, seconded by Riggo accepting the resignation of T. Jordan from the Parks and Recreation Committee was unanimously approved by roll call vote.
