#### 2023 Deferral of School Taxes - Delaware Valley Regional High School

WHEREAS, regulations of the State of New Jersey provide for the deferral of school taxes in an amount not to exceed fifty percent of the annual school tax levy when such taxes are raised on a fiscal year basis (school year July 1 through June 30); and

WHEREAS, said taxes subject to deferral have not been requisitioned by or paid to the school district; and

WHEREAS, it is the desire and intent of the governing body of the Township of Kingwood, County of Hunterdon, to avail the Township of the deferral as permitted by regulations promulgated by the Local Finance Board, Division of Local Government Services, New Jersey Department of Community Affairs; and

WHEREAS, fifty percent of the school tax levy of the Delaware Valley Regional High School District is \$2,179,367.00.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Committee of the Township of Kingwood, County of Hunterdon, hereby authorize the Chief Financial Officer of the Township to defer \$1,271,640.83 of school taxes as permitted by the aforementioned regulation; and

#### RESOLUTION NO. 2023 - 45

#### RESOLUTION NO. 2023 - 51

#### Waiving the Municipal Portion of Dog Licensing Fees for Kingwood Township Volunteer Fire and Rescue Squad Members

WHEREAS, the Township of Kingwood dog license fee is \$15 for neutered dogs and \$18 for non-neutered dogs; and

WHEREAS, of the fees charged by the Township, \$1.20 (neutered) and \$4.20 (non-neutered) for each license is paid to the State of New Jersey; and

WHEREAS, Township Code Section 57-4(D) allows the Township Committee to waive the municipal portion of the license for certain individuals or organizations; and

WHEREAS, the Township wished to waive the municipal portion of the dog licensing fee for all active members of the Kingwood Township Volunteer Fire Department and the Kingwood Township Volunteer Rescue Squad.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Kingwood, in the County of Hunterdon State of New Jersey, waives the municipal portion of the dog licensing fee for all active members of the Kingwood Township Volunteer Fire Department and Kingwood Township Volunteer Rescue Squad. Members are still required to obtain a license and much pay the state portion of each license to the Township.

The applicants, by accepting this waiver, acknowledge and hold harmless the Township of Kingwood and its municipal officials and employees from any and all claims, damages and cost of suit which may arise out of the waiver granted hereunder.

#### **RESOLUTION NO. 2023 – 52**

#### Introduction on Ordinance No. 6 - 2023

Mayor Russano read Ordinance No. 6 - 2023 by title.

#### ORDINANCE NO. 6-2023

## AN ORDINANCE BY THE TOWNSHIP OF KINGWOOD, IN THE COUNTY OF HUNTERDON, STATE OF NEW JERSEY, PROVIDING FOR THE RESURFACING OF FEDERAL TWIST ROAD, APPROPRIATING \$440,000.00

BE IT ORDAINED, by the Committee of the Township of Kingwood in the County of Hunterdon, New Jersey (not less than two-thirds of all members thereof affirmatively concurring) as follows:

#### Section 1.

The improvement described in Section 2 of this ordinance is hereby authorized to be undertaken by the Township of Kingwood, New Jersey as a general improvement. For the improvement or purpose described in Section 2, there is hereby appropriated the sum of \$440,000.00. The funding for the ordinance is a through a receipt of a \$140,562.00 and \$172,118.00 grant from the State of New Jersey Department of Transportation and \$127,320.00 from the Capital Improvement Fund.

#### Section 2.

- (a) The improvement hereby authorized is the resurfacing of Federal Twist Road.
- (b) The estimated cost of the improvement or purpose is equal to the amount of the appropriation herein made therefore.

#### Section 3.

The following additional matters are hereby determined, declared, recited and stated:

- (a) The improvement or purpose described in Section 2 of this ordinance is not a current expense. It is an improvement or purpose that the Township may lawfully undertake as a general improvement, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.
- (b) The period of usefulness of the improvement or purpose within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the bonds authorized by this ordinance, is 20 years.
- (c) An aggregate amount not exceeding \$80,000.00, for items of expense listed in and permitted under N.J.S.A 40A:2-20 is included in the estimated cost indicated herein for the purpose of improvement.

#### Section 4.

The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Township, and the Township shall be obligated to levy ad valorem taxes upon all the taxable real property within the Township for the payment of the obligations and the interest thereon without limitation of rate or amount.

#### Section 5.

This ordinance shall take effect immediately after the first publication thereof after final adoption.

A motion by Riggio, seconded by Syrnick to introduce Ordinance No. 6 – 2023 and move forward with a public hearing set for May 4, 2023, was approved by roll call vote.

#### ORDINANCE NO. 7 – 2023

AN ORDINANCE OF THE TOWNSHIP OF KINGWOOD, COUNTY OF HUNTERDON, STATE OF NEW JERSEY AMENDING THE CODE OF THE TOWNSHIP OF KINGWOOD, CHAPTER 132, ZONING, ARTICLE I, GENERAL PROVISIONS, SECTION 132-4, DEFINITIONS, TO REFLECT A CHANGE TO THE DEFINITION OF LOT DEPTH AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE

**WHEREAS,** Chapter 132-4 of the Code of the Township of Kingwood defines "Lot Depth" in part as follows:" [t]he shortest horizontal distance between the front lot line and a line drawn *parallel* to the front lot line through the midpoint of the rear lot line."

WHEREAS, the Planning Board of the Township of Kingwood has recommended that the definition of Lot Depth be revised as follows: "[t]he shortest horizontal distance between the front lot line and a line drawn *perpendicular* to the front lot line through the midpoint of the rear lot line."

**NOW, THEREFORE, BE IT ORDAINED,** by the Township Committee of the Township of Kingwood, that Chapter 132, Zoning, Article 1, General Provisions, Section 132-4, Definitions, shall be and hereby is amended as follows:

#### Section 1.

§ 132-4 "Definitions" is hereby amended as follows:

#### LOT DEPTH

The shortest horizontal distance between the front lot line and a line drawn parallel perpendicular to the front lot line through the midpoint of the rear lot line. For corner lots, lots fronting on a Class II common driveway, and lots abutting lands used or capable of use for a flag stem with fifty-foot frontage, lot depth shall be measured from each lot line fronting on a public street, on a Class II common driveway, and abutting lands used or capable of use for a flag stem with fifty-foot frontage.

#### Section 2.

Renumbering. This ordinance may be renumbered for codification purposes to the extent necessary.

#### Section 3.

<u>Severability</u>. If the provision of any article, section, subsection, paragraph, subdivision or clause of this Ordinance shall be judged invalid by any Court of competent jurisdiction, such Order or Judgment shall not affect or invalidate the remainder of any such article, section, subsection, paragraph or clause, and, to this end, the provisions of this Ordinance are hereby declared to be severable.

#### Section 4.

<u>Effective Date</u>. This Ordinance shall take effect immediately upon adoption and publication in accordance with the laws of the State of New Jersey.

A motion by Syrnick, seconded by Riggio to introduce Ordinance No. 7 - 2023 and move forward with a public hearing set for May 4, 2023, was approved by roll call vote. Riggio: Yes; Syrnick: Yes; Russano: Yes

#### • Township Committee Liaison Reports:

- Deputy Mayor Syrnick reports that DPW removed over 580 dead Ash trees along the roadways on Kingwood Township properties and Horseshoe Bend Park with the assistance of the Bucket Truck that was rented.
- Committeeman Riggo noted that Community Day was changed to September 30th due to conflicts with the Fire Department.

Committeeman Riggo reported that Parks and Recreation discussed the vacant house at Kingwood Park which they believe will cost approximately \$16,000 to repair.

Committeeman Riggo noted that Parks and Recreation is interested in ordering a trailer to use for wood chips on the trails throughout the Township and that this particular trailer would make it easier for volunteers to work.

Committeeman Riggo stated that the Volunteers have accepted the new volunteer form and are working on obtaining the required certifications.

Committeeman Riggo noted that the Environmental Commission is interested in a EV outlet grant, however, they are undecided on where the best place may be to have them installed.

#### RESOLUTION NO. 2023 - 54

### Authorizing the CFO to Approve and Pay Claims and Required General Books of Account Between Meeting Dates per 40A:5-17

WHEREAS, the Township Committee of the Township of Kingwood may, by resolution, designate one person who may approve claims between meetings of the governing body as per N.J.S.A. 40A:5-17; and,

WHEREAS, it is essential to pay certain claims before monthly committee meetings for the following - Debt Service Payments, State of New Jersey Health Benefits, Kingwood Township School, Delaware Valley Regional High School, County of Hunterdon Taxes, PERS Payments, Utility Bills, Lease Payments and Insurance Bills; and,

WHEREAS, any payment of claims by the Chief Financial Officer between Township meeting dates shall be presented on the bills and claims list at its next scheduled meeting date for ratification by the governing body; and,

WHEREAS, the duties of the approval officer, Chief Financial Officer, shall include making sure that certifications required by 40A:5-16(b) are met, ascertaining the existence of proper and sufficient appropriations for the payments to be made and determining that there is legal authority for payments, evidenced by action of agent or officer in respect to the goods or services ordered and incurring the expense.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Kingwood, County of Hunterdon, State of New Jersey, that the Chief Financial Officer be designated as the person to approve said claims and issue payments; and,

BE IT FURTHER RESOLVED, that the Chief Financial Officer be and is hereby authorized to approve said claims and issue payments in the form of a check, ACH or wire transfer and to execute any and all necessary documents tendered for payment between meeting dates.
