OPEN PUBLIC COMMENT – PRIVILEGE OF THE FLOOR

Mary MacConnell, Spring Hill Road – commented on the lack of information for the benefit of the residents and public on the Township’s website, also asked what is going on with the SECTV renewal application.

David Frank, Muddy Run Road – was present for an update regarding the flooding on Muddy Run Road, and Mayor Russano suggested the committee members would address this during the Township Engineer’s report, later in the meeting. Mr. Frank noted there was an ordinance on the agenda tonight that he thinks is very good, but asked who complaints/reports will be filed with, and Att’y. Moscagiuri responded. Mr. Frank thanked the committee members for pushing the ordinance forward and feels the fine for violations should be set higher.

FIRST RESPONDERS’ REPORTS

- **Kingwood Township Rescue Squad** – Chief Kerry Floyd reported on the rescue squad’s responses within the Township for the month of September, as well as mutual aid. The squad is up to a total of 283 calls so far for this year. She noted that COVID is on the rise again due to the time of year, however, the squad has had no COVID related calls since Community Day.
- **Kingwood Township Fire Inspector** – Fire Marshall Dennis Concannon reported on the number of inspections, reinspections and permits for the month of September, and submitted his written report to the Deputy Clerk.
- **Kingwood Township Volunteer Fire Company** – Fire Chief D. Frank Floyd reported on the fire department responses within the Township for the month of September, as well as any mutual aid. Chief Floyd also reported on the program to replace carbon monoxide and smoke detectors in certain homes in the community. He also updated the committee members with the status of possible grants from FEMA, Governor’s Grant, Forest Fire Service Grant, and work being performed on the high water truck. Chief Floyd brought up a possible Resilient Community Grant, and asked if the committee members have given any thought to supporting the Fire Company in an application, as the Township Committee would be required to apply on their behalf. Following additional discussion, the committee members agreed to move forward with the preapplication that is required.

It was moved by Ms. Syrnick, seconded by Mr. Riggio and carried to authorize the preparation and submission of a preapplication to the Resilient Community Grant Program, for a possible project for the Fire Company. **All** voted **Aye** on **Roll Call Vote**.

- **Kingwood Township OEM** – OEM Coordinator D. Frank Floyd updated the committee Members regarding a variety of subjects, including FEMA funds for Kingwood Station-Barbertown Road, Horseshoe Bend Road culvert project which is actually replacement of a bridge, repair/maintenance of the Township’s emergency generators, order status

of the AED previously discussed items, possible EMMA award, Community Day and appointment of a new Deputy Emergency Management Coordinator.

AWARDING PROFESSIONAL SERVICE CONTRACT TO COMMUNITY GRANTS, PLANNING AND HOUSING, LLC (CGP&H) FOR AFFORDABLE HOUSING ADMINISTRATIVE AGENT SERVICES WITHOUT COMPETITIVE BIDDING

WHEREAS, the Township has a need for a professional Affordable Housing Administrative Agent to administer affordable housing obligations as required by New Jersey law and that certain Superior Court – approved settlement agreement by and among the Township and Fair Share Housing Center, et al; and

WHEREAS, the Local Public Contracts Law, codified under N.J.S.A. 40A:11-1, et seq., specifically N.J.S.A. 40A:11-5, permits the award of professional services without public advertisement as defined in N.J.S.A. 19:44A-20.7 or competitive bidding, pursuant to the provisions of N.J.S.A. 19:44A-20.4; and

WHEREAS, the Township received a proposal from CGP&H dated June 26, 2023, for the provision of Administrative Agent Services for an annual amount not to exceed ten thousand dollars (\$10,000.00); and

WHEREAS, the Township Planner, David Banisch, and Township Counsel, each reviewed the submission of CGP&H and have recommended that the Committee award the contract to CPG&H; and

WHEREAS, the Township’s Chief Financial Officer certifies that sufficient funds are available for this purpose; and

WHEREAS, the Township Committee believes it to be in the best interest of the Township to award the contract for Affordable Housing Administrative Agent Services to CPG&H.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Kingwood, County of Hunterdon, State of New Jersey, as follows:

(b) The estimated cost of the improvement or purpose is equal to the amount of the appropriation herein made therefore.

Section 3. The following additional matters are hereby determined, declared, recited and stated:

(a) The improvement or purpose described in Section 2 of this ordinance is not a current expense. It is an improvement or purpose that the Township may lawfully undertake as a general improvement, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.

(b) The period of usefulness of the improvement or purpose within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the bonds authorized by this ordinance, is 20 years.

(c) An aggregate amount not exceeding \$75,000.00, for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purpose of improvement.

Section 4. The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Township, and the Township shall be obligated to levy ad valorem taxes upon all the taxable real property within the Township for the payment of the obligations and the interest thereon without limitation of rate or amount.

Section 5. This ordinance shall take effect immediately after the first publication thereof after final adoption.

The word "shall" is always mandatory and not merely directory.

- a. Feed – to give, place, expose, deposit, distribute or scatter any edible material with the intention of feeding, attracting or enticing wildlife. Feeding does not include baiting in the legal taking of fish and/or game.
- b. Person – any individual, corporation, company, partnership, firm, association, or political subdivision of this State subject to municipal jurisdiction.
- c. Wildlife – all animals that are neither human nor domesticated.

SECTION III. Prohibited Conduct:

- a. No person shall feed, in any public park or on any other property owned or operated by Kingwood Township, any wildlife, excluding confined wildlife (for example, wildlife confined in zoos, parks or rehabilitation centers, or unconfined wildlife at environmental education centers, or feral cats as part of an approved Trap-Neuter-Release program).

SECTION IV. Enforcement:

- a. This ordinance shall be enforced by the State Police for Kingwood Township.
- b. Any person found to be in violation of this ordinance shall be ordered to cease the feeding immediately.

SECTION V. Violations and Penalties:

Any person(s) who is found to be in violation of the provisions of this ordinance shall be subject to a fine not to exceed \$50 - \$100.

SECTION VI. Severability:

Each section, subsection, sentence, clause and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase, and the finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this Ordinance.

Municipal separate storm sewer system (MS4) – a conveyance or system of conveyances (including roads with drainage systems, municipal streets, catch basins, curbs, gutters, ditches, manmade channels, or storm drains) that is owned or operated by Kingwood Township or other public body, and is designed and used for collecting and conveying stormwater.
- b. Person – any individual, corporation, company, partnership, firm, association, or political subdivision of this State subject to municipal jurisdiction.
- c. Refuse container – any waste container that a person controls whether owned, leased, or operated, including dumpsters, trash cans, garbage pails, and plastic trash bags.
- d. Stormwater – means water resulting from precipitation (including rain and snow) that runs off the land’s surface, is transmitted to the subsurface, is captured by separate storm sewers or other sewerage or drainage facilities, or is conveyed by snow removal equipment.
- e. Waters of the State – means the ocean and its estuaries, all springs, streams and bodies of surface or ground water, whether natural or artificial, within the boundaries of the State of New Jersey or subject to its jurisdiction.

SECTION III. Prohibited Conduct:

Any person who controls, whether owned, leased, or operated, a refuse container or dumpster must ensure that such container or dumpster is covered at all times and shall prevent refuse from spilling out or overflowing. Any person who owns, leases or otherwise uses a refuse container or dumpster must ensure that such container or dumpster does not leak or otherwise discharge liquids, semi-liquids or solids to the municipal separate storm sewer system(s) operated by Kingwood Township.

SECTION IV. Exceptions to Prohibition:

- a. Permitted temporary demolition containers
- b. Litter receptacles (other than dumpsters or other bulk containers)
- c. Individual homeowner trash and recycling containers
- d. Refuse containers at facilities authorized to discharge stormwater under a valid NJPDES permit
- e. Large bulky items (e.g., furniture, bound carpet and padding, white goods placed curbside for pickup)

SECTION V. Enforcement:

This ordinance shall be enforced by the Zoning Official of Kingwood Township.

SECTION VI. Penalties:

Any person(s) who is found to be in violation of the provisions of this ordinance shall be subject to a fine of \$100 - \$1,000.

SECTION VII. Severability:

- a. Immediate – shall mean that the pet solid waste is removed at once, without delay.
- b. Owner/Keeper – any person who shall possess, maintain, house or harbor any pet or otherwise have custody of any pet, whether or not the owner of such pet.
- c. Person – any individual, corporation, company, partnership, firm, association, or political subdivision of this State subject to municipal jurisdiction.
- d. Pet - a domesticated animal (other than a disability assistance animal) kept for amusement or companionship.
- e. Pet solid waste – waste matter expelled from the bowels of the pet; excrement
- f. Proper disposal – placement in a designated waste receptacle, or other suitable container, and discarded in a refuse container which is regularly emptied by the municipality or some other refuse collector; or disposal into a system designed to convey domestic sewage for proper treatment and disposal.

SECTION III. Requirement for Disposal:

All pet owners and keepers are required to immediately and properly dispose of their pet's solid waste deposited on any property, public or private, not owned or possessed by that person.

SECTION IV. Exemptions:

Any owner or keeper who requires the use of a disability assistance animal shall be exempt from the provisions of this section while such animal is being used for that purpose.

SECTION V. Enforcement:

The provisions of this Article shall be enforced by the State Police for Kingwood Township.

SECTION VI. Violations and Penalty:

Any person(s) who is found to be in violation of the provisions of this ordinance shall be subject to a fine not to exceed \$50 - \$500.

SECTION VII. Severability:

containers or other packaging or construction material, but does not include the waste of the primary processes of mining or other extraction processes, logging, sawmilling, farming or manufacturing.

- b. Litter Receptacle – a container suitable for the depositing of litter.
- c. Person – any individual, corporation, company, partnership, firm, association, or political subdivision of this State subject to municipal jurisdiction.

SECTION III. Prohibited Acts and Regulated Activities:

1. It shall be unlawful for any person to throw, drop, discard or otherwise place any litter of any nature upon public or private property other than in a litter receptacle, or having done so, to allow such litter to remain.
2. Whenever any litter is thrown or discarded or allowed to fall from a vehicle or boat in violation of this ordinance, the operator or owner, or both, of the motor vehicle or boat shall also be deemed to have violated this ordinance.

SECTION IV. Enforcement:

ORDINANCE NO. 17 - 2023

AN ORDINANCE TO ESTABLISH A YARD WASTE COLLECTION AND DISPOSAL PROGRAM IN KINGWOOD TOWNSHIP, SO AS TO PROTECT PUBLIC HEALTH, SAFETY AND WELFARE, AND TO PRESCRIBE PENALTIES FOR THE FAILURE TO COMPLY

SECTION I. Purpose:

An ordinance to establish a yard waste collection and disposal program in Kingwood Township, so as to protect public health, safety and welfare, and to prescribe penalties for the failure to comply.

SECTION II Definitions:

For the purpose of this ordinance, the following terms, phrases, words and their derivations shall have the meanings stated herein unless their use in the text of this Chapter clearly demonstrates a different meaning. When not inconsistent with the context, words used in the present tense include the future, words used in the plural number include the singular number, and words used in the singular number include the plural number. The word "shall" is always mandatory and not merely directory.

- a. Containerized – means the placement of yard waste in a trash can, bucket, bag or other vessel, such as to prevent the yard waste from spilling or blowing out into the street and coming into contact with stormwater.
- b. Person – any individual, corporation, company, partnership, firm, association, or political subdivision of this State subject to municipal jurisdiction.
- c. Street – means any street, avenue, boulevard, road, parkway, viaduct, drive, or other way, which is an existing State, county, or municipal roadway, and includes the land between the street lines, whether improved or unimproved, and may comprise pavement, shoulders, gutters, curbs, sidewalks, parking areas, and other areas within the street lines.
- d. Yard Waste – means leaves and grass clippings.

SECTION III. Yard Waste Collection

Sweeping, raking, blowing or otherwise placing yard waste that is not containerized at the curb or along the street is only allowed during the seven (7) days prior to a scheduled and announced collection, and shall not be placed closer than 10 feet from any storm drain inlet. Placement of such yard waste at the curb or along the street at any other time or in any other manner is a violation of this ordinance. If such placement of yard waste occurs, the party responsible for placement of the yard waste must remove the yard waste from the street or said party shall be deemed in violation of this ordinance.

SECTION IV. Enforcement:

The provisions of this ordinance shall be enforced by the Zoning Official or Construction Official.

SECTION V. Violations and Penalties:

Any person(s) who is found to be in violation of the provisions of this ordinance shall be subject to a fine not to exceed \$100 - \$500.

SECTION VI. Severability:

Each section, subsection, sentence, clause and phrase of this Ordinance is declared to be independent section, subsection, sentence, clause and phrase, and the finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this Ordinance.

SECTION VII. Effective date:

This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.

Ordinance No. 17-2023 was adopted on first reading at a meeting of the Kingwood Township Committee held on September 7, 2023. It was finally adopted at a meeting of the Kingwood Township Committee held on October 5, 2023.

Introduction and Adoption on First Reading of Ordinance No. 18-2023 – Mayor Russano read the Ordinance aloud by title:

ORDINANCE NO. 18 – 2023

AN ORDINANCE REQUIRING THE RETROFITTING OF EXISTING STORM DRAIN INLETS WHICH ARE IN DIRECT CONTACT WITH REPAVING, REPAIRING, RECONSTRUCTION, OR RESURFACING OR ALTERATIONS OF FACILITIES ON PRIVATE PROPERTY, TO PREVENT THE DISCHARGE OF SOLIDS AND FLOATABLES (SUCH AS PLASTIC BOTTLES, CANS, FOOD WRAPPERS AND OTHER LITTER) TO THE MUNICIPAL SEPARATE STORM SEWER SYSTEM(S) OPERATED BY KINGWOOD TOWNSHIP SO AS TO PROTECT PUBLIC HEALTH, SAFETY AND WELFARE, AND TO PRESCRIBE PENALTIES FOR THE FAILURE TO COMPLY

Whereas, the Township of Kingwood seeks to establish requirement for retrofitting of existing storm drain inlets which are in direct contact with repaving, repairing, reconstruction or resurfacing of alterations of facilities on private property, to prevent the discharge of solids and floatables to the municipal separate storm sewer system(s) operated by the Township of Kingwood, if any, so as to protect public health, safety and welfare, and to prescribe penalties for the failure to comply.

Now, Therefore, BE IT ORDAINED by the Committee of the Township of Kingwood in the County of Hunterdon, New Jersey (not less than two-thirds of all members thereof affirmatively concurring) as follows:

SECTION I. Purpose:

An ordinance requiring the retrofitting of existing storm drain inlets which are in direct contact with repaving, repairing, reconstruction, or resurfacing or alterations of facilities on private property, to prevent the discharge of solids and floatables (such as plastic bottles, cans, food wrappers and other litter) to the municipal separate storm sewer system(s) operated by the Township of Kingwood, if any, so as to protect public health, safety and welfare, and to prescribe penalties for the failure to comply.

SECTION II. Definitions:

For the purpose of this ordinance, the following terms, phrases, words, and their derivations shall have the meanings stated herein unless their use in the text of this Chapter clearly demonstrates a different meaning. When not inconsistent with the context, words used in the present tense include the future, words used in the plural number include the singular number, and words used in the singular number include the plural number. The word “shall” is always mandatory and not merely directory.

- a. Municipal separate storm sewer system (MS4)– a conveyance or system of conveyances (including roads with drainage systems, municipal streets, catch basins, curbs, gutters, ditches, manmade channels, or storm drains) that is owned or operated by [insert name of municipality] or other public body, and is designed and used for collecting and conveying stormwater.
- b. Person – any individual, corporation, company, partnership, firm, association, or political subdivision of this State subject to municipal jurisdiction.
- c. Storm drain inlet- an opening in a storm drain used to collect stormwater runoff and includes, but is not limited to, a grate inlet, curb-opening inlet, slotted inlet, and combination inlet.
- d. Waters of the State – means the ocean and its estuaries, all springs, streams and bodies of surface or ground water, whether natural or artificial, within the boundaries of the State of New Jersey or subject to its jurisdiction.

SECTION III. Prohibited Conduct:

No person in control of private property (except a residential lot with one single family house) shall authorize the repaving, repairing (excluding the repair of individual potholes), resurfacing (including top coating or chip sealing with asphalt emulsion or a thin base of hot bitumen), reconstructing or altering any surface that is in direct contact with an existing storm drain inlet on that property unless the storm drain inlet either:

1. Already meets the design standard below to control passage of solid and floatable materials; or
2. Is retrofitted or replaced to meet the standard in Section IV below prior to the completion of the project.

SECTION IV. Design Standard:

Storm drain inlets identified in Section III above shall comply with the following standard to control passage of solid and floatable materials through storm drain inlets. For purposes of this paragraph, "solid and floatable materials" means sediment, debris, trash, and other floating, suspended, or settleable solids. For exemptions to this standard see Section V.3 below.

1. Design engineers shall use either of the following grates whenever they use a grate in pavement or another ground surface to collect stormwater from that surface into a storm drain or surface water body under that grate:
 - a. The New Jersey Department of Transportation (NJDOT) bicycle safe grate, which is described in Chapter 2.4 of the NJDOT Bicycle Compatible Roadways and Bikeways Planning and Design Guidelines (April 1996); or
 - b. A different grate, if each individual clear space in that grate has an area of no more than seven (7.0) square inches, or is no greater than 0.5 inches across the smallest dimension.
 - c. Examples of grates subject to this standard include grates in grate inlets, the grate portion (non-curb-opening portion) of combination inlets, grates on storm sewer manholes, ditch grates, trench grates, and grates of spacer bars in slotted drains. Examples of ground surfaces include surfaces of roads (including bridges), driveways, parking areas, bikeways, plazas, sidewalks, lawns, fields, open channels, and stormwater basin floors.
2. Whenever design engineers use a curb-opening inlet, the clear space in that curb opening (or each individual clear space, if the curb opening has two or more clear spaces) shall have an area of no more than seven (7.0) square inches, or be no greater than two (2.0) inches across the smallest dimension.
3. This standard does not apply:

- a. Where the municipal engineer agrees that this standard would cause inadequate hydraulic performance that could not practicably be overcome by using additional or larger storm drain inlets that meet these standards;
- b. Where flows are conveyed through any device (e.g., end of pipe netting facility, manufactured treatment device, or a catch basin hood) that is designed, at a minimum, to prevent delivery of all solid and floatable materials that could not pass through one of the following:
 - i. A rectangular space four and five-eighths inches long and one and one-half inches wide (this option does not apply for outfall netting facilities); or
 - ii. A bar screen having a bar spacing of 0.5 inches.
- c. Where flows are conveyed through a trash rack that has parallel bars with one-inch (1") spacing between the bars; or
- d. Where the New Jersey Department of Environmental Protection determines, pursuant to the New Jersey Register of Historic Places Rules at N.J.A.C. 7:4-7.2(c), that action to meet this standard is an undertaking that constitutes an encroachment or will damage or destroy the New Jersey Register listed historic property.

SECTION V. Enforcement:

This ordinance shall be enforced by the Zoning Official of the Township of Kingwood.

SECTION VI. Penalties:

Any person(s) who is found to be in violation of the provisions of this ordinance shall be subject to a fine not to exceed \$50 - \$500 for each storm drain inlet that is not retrofitted to meet the design standard.

SECTION VII. Severability:

Each section, subsection, sentence, clause and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase, and the finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this Ordinance.

SECTION VIII. Effective date:

This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.

Introduction and Adoption on First Reading of Ordinance No. 19-2023 – Mayor Russano read the Ordinance aloud by title:

ORDINANCE NO. 19 - 2023

AN ORDINANCE ESTABLISHING REQUIREMENTS FOR THE STORAGE OF SALT AND OTHER SOLID DE-ICING MATERIALS ON PROPERTIES NOT OWNED OR OPERATED BY THE MUNICIPALITY (PRIVATELY-OWNED), INCLUDING RESIDENCES IN THE TOWNSHIP OF KINGWOOD, TO PROTECT THE ENVIRONMENT, PUBLIC HEALTH, SAFETY AND WELFARE, AND TO PRESCRIBE PENALTIES FOR FAILURE TO COMPLY

Whereas, the Township of Kingwood seeks to establish requirement for the storage of salt and other solid de-icing materials on properties not owned or operated by the municipality (privately-owned) ,including residences, in the Township of Kingwood to protect the environment, public health, safety and welfare, and to prescribe penalties for failure to comply.

Now Therefore, BE IT ORDAINED by the Committee of the Township of Kingwood in the County of Hunterdon, New Jersey (not less than two-thirds of all members thereof affirmatively concurring) as follows:

SECTION I. Purpose:

The purpose of this ordinance is to prevent stored salt and other solid de-icing materials from being exposed to stormwater.

This ordinance establishes requirements for the storage of salt and other solid de-icing materials on properties not owned or operated by the municipality (privately-owned), including residences, in Kingwood Township to protect the environment, public health, safety and welfare, and to prescribe penalties for failure to comply.

SECTION II. Definitions:

For the purpose of this ordinance, the following terms, phrases, words and their derivations shall have the meanings stated herein unless their use in the text of this Chapter clearly demonstrates a different meaning. When consistent with the context, words used in the present tense include the future, words used in the plural number include the singular number, and words used in the singular number include the plural number. The word “shall” is always mandatory and not merely directory.

- A. “De-icing materials” means any granular or solid material such as melting salt or any other granular solid that assists in the melting of snow.

- B. "Impervious surface" means a surface that has been covered with a layer of material so that it is highly resistant to infiltration by water.
- C. "Storm drain inlet" means the point of entry into the storm sewer system.
- D. "Permanent structure" means a permanent building or permanent structure that is anchored to a permanent foundation with an impermeable floor, and that is completely roofed and walled (new structures require a door or other means of sealing the access way from wind driven rainfall).

A fabric frame structure is a permanent structure if it meets the following specifications:

- 1. Concrete blocks, jersey barriers or other similar material shall be placed around the interior of the structure to protect the side walls during loading and unloading of de-icing materials;
 - 2. The design shall prevent stormwater run-on and run through, and the fabric cannot leak;
 - 3. The structure shall be erected on an impermeable slab;
 - 4. The structure cannot be open sided; and
 - 5. The structure shall have a roll up door or other means of sealing the access way from wind driven rainfall.
- E. "Person" means any individual, corporation, company, partnership, firm, association, or political subdivision of this State subject to municipal jurisdiction.
 - F. "Resident" means a person who resides on a residential property where de-icing material is stored.

SECTION III. Deicing Material Storage Requirements:

- A. Temporary outdoor storage of de-icing materials in accordance with the requirements below is allowed between October 15th and April 15th:
 - 1. Loose materials shall be placed on a flat, impervious surface in a manner that prevents stormwater run-through;
 - 2. Loose materials shall be placed at least 50 feet from surface water bodies, storm drain inlets, ditches and/or other stormwater conveyance channels;
 - 3. Loose materials shall be maintained in a cone-shaped storage pile. If loading or unloading activities alter the cone-shape during daily activities, tracked materials shall be swept back into the storage pile, and the storage pile shall be reshaped into a cone after use;
 - 4. Loose materials shall be covered as follows:

- a. The cover shall be waterproof, impermeable, and flexible;
 - b. The cover shall extend to the base of the pile(s);
 - c. The cover shall be free from holes or tears;
 - d. The cover shall be secured and weighed down around the perimeter to prevent removal by wind; and
 - e. Weight shall be placed on the cover(s) in such a way that minimizes the potential of exposure as materials shift and runoff flows down to the base of the pile.
 - (1) Sandbags lashed together with rope or cable and placed uniformly over the flexible cover, or poly-cord nets provide a suitable method. Items that can potentially hold water (e.g., old tires) shall not be used;
5. Containers must be sealed when not in use; and
 6. The site shall be free of all de-icing materials between April 16th and October 14th.
- B. De-icing materials should be stored in a permanent structure if a suitable storage structure is available. For storage of loose de-icing materials in a permanent structure, such storage may be permanent, and thus not restricted to October 15 - April 15.
- C. The property owner, or owner of the de-icing materials if different, shall designate a person(s) responsible for operations at the site where these materials are stored outdoors, and who shall document that weekly inspections are conducted to ensure that the conditions of this ordinance are met. Inspection records shall be kept on site and made available to the municipality upon request.
1. Residents who operate businesses from their homes that utilize de-icing materials are required to perform weekly inspections.

SECTION IV. Exemptions:

Residents may store de-icing materials outside in a solid-walled, closed container that prevents precipitation from entering and exiting the container, and which prevents the de-icing materials from leaking or spilling out. Under these circumstances, weekly inspections are not necessary, but repair or replacement of damaged or inadequate containers shall occur within 2 weeks.

If containerized (in bags or buckets) de-icing materials are stored within a permanent structure, they are not subject to the storage and inspection requirements in Section III above. Piles of de-icing materials are not exempt, even if stored in a permanent structure.

This ordinance does not apply to facilities where the stormwater discharges from de-icing material storage activities are regulated under another NJPDES permit.

SECTION V. Enforcement:

This ordinance shall be enforced by the Zoning Official of Kingwood Township during the course of ordinary enforcement duties.

SECTION VI. Violations and Penalties:

Any person(s) who is found to be in violation of the provisions of this ordinance shall have 72 hours to complete corrective action. Repeat violations and/or failure to complete corrective action shall be found to be in violation of the provisions of this ordinance shall be subject to a fine of \$50.00 - \$500.00.

SECTION VII. Severability:

Each section, subsection, sentence, clause, and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause, and phrase, and finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause or reason shall not affect any other portion of this Ordinance.

SECTION VIII. Effective Date:

This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.

NEW BUSINESS

Township Committee Liaison Reports:

Ms. Syrnick reported on various activities for DPW including mowing of all the roads, cutting back Multiflora Rose and Russian Olive on all the roads, Federal Twist Road paving project, power washing of the Municipal Building through the Labor Assistance Program (SLAP) that should be completed by the end of this month. Ms. Syrnick also reported on the house at Kingwood Park as far as the heating system, there appear to be multiple leaks. The Township will invest \$2,500 for a pressurized test to be performed in order to isolate the leaks and determine how much needs to be fixed. In addition, the DPW will install a new door on the chicken coop at the Park. The Delaware Valley Volleyball Team had obtained a Clean Communities Grant, which they used to clean up trash at Kingwood Park, approximately 95% was cleaned up by them after Community Day.

Mr. Riggio reported on Parks and Recreation in regard to Community Day that took place at Kingwood Park. He noted the variety of things that had to be done to pull everything together and thanked everyone who helped out, he is very proud of being part of the team that organized that day. Parks and Recreation was already discussing at their meeting last night how to improve things for next year. There were about 212 vehicles parked at fireworks time, a pretty good turnout, and there was positive feedback from some residents. He commented on the great job that was done by the office staff in e-organizing the Community Day link.

Mr. Riggio commented the Parks and Recreation Committee last night had a lengthy discussion on the house at Kingwood Park, and they expressed concerns regarding the status of it, due to the coming weather. Mr. Riggio will provide them with the previously reported information regarding the heating system, and Ms. Syrnick encouraged him to ask them for a decision/proposal of what they would like to do with the house before the Township spends money on it.

Mr. Riggio reported on a recent meeting of the Rockfall Subcommittee with the State DOT that took place this Monday, first meeting they have had since July 20th. He commented that meeting provided the subcommittee with a presentation for Sections A, B and C of the plan, which is north of the Devil's Tea Table, while Section D of the plan will require a separate meeting to present. This project will cost approximately \$40m dollars. The subcommittee members asked Mr. Riggio to bring this info to the Township Committee, and he feels the committee members, by seeing these pictures, will then have a feeling of the logic and options being offered. Mr. Riggio reviewed the pictures from the State of the various options being offered, while describing the concerns/issues the subcommittee talked about, and he listened to and responded to the comments/questions from the committee members and some of the first responders still in attendance. The subcommittee members also asked Mr. Riggio to bring this info to the public, as well, and it was agreed to post to the Township's website.

Richard Dodds, a member of the subcommittee, was present and confirmed the information that was shown tonight has been provided to the Hunterdon County Planning Board, for their review. Mr. Dodds noted that none of the six options offered by the State is acceptable to anyone on the subcommittee, so they decided to expand it out to the County for support.

Mayor Russano will write a letter/letters to the Governor's Liaison, NJDOT and the Township's other legislators. Mr. Riggio will email the presentation to the committee members.

Mr. Riggio briefly reported on matters from the Board of Education, which included an internet outage that has now been mitigated, their open houses were well attended, they have obtained two out of three grants which will be utilized for improving the school nurse's facilities, still are concerns about the limited space available for preschoolers, and we are still waiting for the previously offered HEPA filters.

Mr. Riggio briefly reported on matters from the Environmental Commission, preparation of their Annual Report, presentation about protecting the banks of Copper Creek through the Copper Creek Restoration Project, and the Application for BI 12 L 11 for a Class B Tree Recycling Permit. Environmental Commission members are trying to organize visits to the site for three commission members, Mr. Riggio does not know the date of the public hearing as of yet.

Mayor Russano reported there were two DWI offenses in the Township, this is in response to a question from a resident at the September 7, 2023 Township Committee Meeting. He also reported the Housing Board held a special meeting, and the committee members will be receiving a memo regarding any updates on the COAH potential housing involving Galleria Construction in the village.

Discussion on Potential RFP for Professional Services

It was agreed to return to this subject on the November Agenda in order to allow the committee members a little time to consider.

Discussion on Claims Procedure for Disbursements

It was moved by Mr. Riggio, seconded by Ms. Syrnick and carried that the Clerk's Office will disperse/mail out the checks following the meetings, to comply with the Township's current Ordinance and to attempt to separate some of the finance duties as per the Annual Audit recommendation.

Discussion/Approval of Resolution #2023-119 Opposing H.R. 3372

RESOLUTION NO. 2023 – 119

Opposing H.R. 3372, Which Would Establish a 10-Year Pilot Program for States to Test 91,000 Pound Trucks

WHEREAS, H.R. 3372 was introduced in the House of Representative on May 16, 2023 and could create a program for states to "test" 91,000-pound trucks on their roads; and

WHEREAS, this increase to 91,000 pounds represents a nearly 14% increase over the current large rigs which are approximately 80,000 pounds in weight; and

WHEREAS, a 2023 joint study prepared by the National Association of Counties and National Association of County Engineers found that 72,000 local bridges across the country are unable to safely handle 91,000-pound trucks and that it would cost \$61 billion to replace them; and

WHEREAS, according to the USDOT even with a 6th axle distributing the load, 91,000-pound trucks would only pay for about 55% of their damage to roads and bridges; and

WHEREAS, since Congress last raised truck weights, the number of trucks registered in the U.S. and the miles they drive have increased by 91%; and

WHEREAS, Kingwood Township has numerous small bridges that currently cannot handle existing heavy trucks that are on our roadways; and

NOW, THEREFORE, BE IT RESOLVED that the Kingwood Township Committee hereby opposes H.R. 3372 and calls upon it's federally elected representatives to oppose this legislation, and

BE IT FURTHER RESOLVED that a copy of this Resolution shall be sent to U.S. Representative Tom Kean, U.S. Senators Robert Menendez and Cory Booker.

Discussion/Approval of Resolution #2023-12 Support of Assembly Bills 975 and 264

RESOLUTION NO. 2023 – 122

Supporting Assembly Bill No. 975 and Senate Bill No. 2643 Requiring Certain Commercial Motor Vehicles to be Equipped with Global Positioning Systems

WHEREAS, bipartisan Assembly Bill No. 975 sponsored by Assemblyman John DiMaio and Assemblyman Daniel Benson would require a commercial motor vehicle operating upon the public highways of this State, to be equipped with a global positioning system navigation program that provides information about upcoming highway infrastructure with low vertical clearance and weight restrictions and dynamic route directions that account for commercial motor vehicle restrictions; and

WHEREAS, the legislation defines a “commercial motor vehicle” as a select group of vehicles with a gross vehicle weight rating of 26,001 or more pounds, or that display a gross vehicle weight rating of 26,001 or more pounds; and

WHEREAS, commercial motor vehicles have restricted routes of travel that are not readily displayed on civilian navigation systems that are sometimes used by operators of commercial motor vehicles; and

WHEREAS, because of limited information on civilian navigation systems, commercial motor vehicle operators often unintentionally end up on restricted weight roadways or have stopped along their route by a restricted weight bridge; and

WHEREAS, Hunterdon County has sustained damages to roadways and bridges as a result of overweight trucks traveling on them; and

WHEREAS, unless identified by a camera, or law enforcement personnel, Hunterdon County taxpayers are on the hook for the cost of repairs to infrastructure damaged by large trucks; and

WHEREAS, this legislation is also important given the number of historic bridges, culverts, and downtowns located throughout Hunterdon County that cannot accommodate large commercial vehicles and cause considerable disruption to local traffic flow.

NOW, THEREFORE, BE IT RESOLVED, that the Kingwood Township Committee does hereby support Assembly Bill No, 975 and Senate Bill No. 2643; and

BE IT FURTHER RESOLVED, that a copy of this resolution shall be sent to members of the 23rd Legislative District.
