#### Privilege of the Floor

Michele Tipton-Walters represented a request from Linzi McCormick to use the Morton building for youth (8-10 yrs. old) soccer practice. Ms. McCormick is a professional soccer coach and stated that they would need to use the building each Monday for one hour for the next 5 weeks. They would be using a very heavy futsal ball which would not be airborne.

Motion to Allow Timothy Jordan to Represent the Parks and Recreation Committee in a Meeting with Linzi McCormick to Determine if the Morton Building is Suitable for Youth Soccer Practice. It was moved by David Hewitt, seconded by Jack Niciecki to allow Timothy Jordan to represent the Parks and Recreation Committee in a meeting with Linzi McCormick to determine Morton building suitability for youth soccer practice.

Timothy Jordan asked the Committee if there is a process in place to determine when meetings should be held live and when they should be held remotely via Zoom based on Public Health considerations. Mr. Dodds stated that last year the Township Committee left that decision up to each individual Committee/Board. Parks and Recreation does not currently have a specific policy.

Motion to Officially hold Parks and Recreation Meetings during February, March and April Remotely via Zoom. Meetings from May through November to be Held at the Kingwood Park Pavilion. Committee to determine November and December meeting location in October of 2022.

It was moved by Chuck Kolvites, seconded by Timothy Jordan to approve holding Parks and Recreation meeting remotely via Zoom for February, March and April 2022. Meetings to be held at Kingwood Park Pavilion from May through October. Committee to decide meeting location for November and December by October 2022.

# Horseshoe Bend Park/Ukarish Property Update

Jack McConnell, reported to the Committee that a hunter had violated hunting rules by not posting his name and hunting license number on his tree stand and by cutting vegetation around the stand. This individual was apprised that Parks and Recreation Committee would contact him regarding the violations.

The Committee discussed that although the posting of identification on tree stands is addressed at the mandatory Hunters meeting each year the subject regarding State rules that no trees or vegetation can be cut on State land is not discussed. Moving forward this information will be included in the mandatory hunting presentation.

Mr. McConnell asked for input from the Committee regarding opposing a fine requiring restitution by working time at Horseshoe Bend Park. Some members of the Committee felt is sufficient to give a warning. Mr. McConnell felt that would then become the precedent for possibly greater violations.

The Committee asked Andrew Russano, Committee Liaison, to ask the Township Attorney for input on how best to handle violations by hunters at the Horseshoe Bend Park. This topic was tabled to the February 2, 2022 meeting.

R Dodds discussed a statement on the Friends of Horseshoe Bend Park website regarding signage of vendors. Mr. Dodds read a letter set to Friends of Horseshoe Bend Park by the Township Attorney, Katrina Campbell. The letter stated that the private organization cannot permit corporate sponsorship on Township property.

Mr. Dodds made note of many other Township activities over the years that have allowed temporary sponsored signage.

Andy Russano, Committee Liaison, to gather more information on this subject and report back to the Committee at the February  $2^{nd}$  meeting.

R. Dodds discussed the State grant for the Lindsey White House at Horseshoe Bend East. He stated that operating costs above revenue from rentals can likely come from the Open Space Trust fund. Mr. Dodds asked for a recommendation to the Township Committee that they approve the Township matching funds of approximately \$202,121. for this initial State Historic preservation grant.

Some Committee members have not yet seen the building. These members will tour the building and report back at the February 2<sup>nd</sup> meeting.

It was suggested by Michael Ewing, DPW Foreman that the money allotted to Kingwood Park be used for stone dust to be applied to the walking, running trail.

Motion to Approve the Purchase of Stone Dust for the Walking/Running Trail in the amount of \$2,100. instead of a New Refrigerator.

It was moved by Timothy Jordan, seconded by Richard Dodds to approve the use of an encumbered amount of \$2,100.00 from the 2021 budget towards the purchase of stone dust for the Kingwood Park walking/jogging trail.

Mr. Dodds stated that there are four picnic tables at Horseshoe Bend Park not in regular use. He suggested one of those tables be moved to the Kingwood Park Pavilion. The Committee discussed using the \$300.00 for maintenance materials for the picnic tables.

Secretary Walters to review with Diane Laudenbach, CFO, to determine if changing the use specified in the donation would be permitted by the State.
