Privilege of the Floor

J. MacConnell stated that the boiler at Horseshoe Bend Park needed repair.

Mr. MacConnell requested that the Parks and Recreation Committee draft and send a letter to State regarding the damage the Cooley property is causing to the area surrounding the property and to the Horseshoe Bend Park. The Committee discussed whether a letter would be beneficial. R. Dodds stated the goal should be to note that the tax payers have paid for the property and, as such, should be permitted to use the parking lot on the Cooley property at no charge. The Concessionaire should either pay for the parking lot, reimburse the State for the land, or they should pay business taxes to Kingwood Township.

Motion for Parks and Recreation Committee to Recommend to the Township Committee that a letter be written to the NJ Department of Environmental Protection Stating Grievances.

It was moved by David Hewitt, seconded by Mara Tippett and approved to request that a memo be sent to the Township Committee Recommending that a Letter of Greivance regarding the Cooley Property be Sent from the Township Committee to the NJ State Department of Environmental Protection.

Mr. MacConnell request that the fire truck, that had been stored at Horseshoe Bend Park for three years, be brought back. Green Acres required that all equipment that did not directly support outdoor recreation be moved off of the property. R. Dodds stated that the fire truck does support the park safety. L. Riggio will discuss this with the Township Committee at the February 2nd meeting during the Parks and Rec liaison report.

- J. Scricco voiced his frustration about the status of hunting on the State land at Horseshoe Bend Park. Mr. Scricco accused the previous Township Committee of lying in the past. He stated that all the issues presented, so far, have been blamed on Richard Dodds. Mr. Scricco stated that he "Can't get the truth out of Dave (Hewitt), Andy (Russano) or Michele (Tipton-Walters)." Mr. Scricco is requesting that the Parks and Recreation Committee do whatever they can to get the Kingwood Township managed hunting back on the State land.
- J. Scricco voiced his concern and grievance over no longer being permitted to park up at the Cooley property without having to pay a fee for \$6.00 each time he chooses to park there. He has asked for representation by the Parks and Recreation Committee for the Kingwood residents.
