EC member Cynthia Niciecki was the township's volunteer recycling coordinator.

- Collected & submitted recycling figures to the state: In 2008 1,368.72 tons were recycled compared to 729.90 tons in 2007, showing an increase of 638.82 tons.
- Coordinated pick-up of recycling bins when full (2-3 times a month)
- Outreach & education—including Girl Scouts & Cub Scouts

Mr. Spayd encouraged everyone to get their well water tested. He noted that the results are very confidential.

Discussed problem of deer overpopulation. Jack Niciecki volunteered to coordinate hunters with landowners who would like to make their land available for hunting.

Assisted environmental education/stream monitoring with students in Kingwood Twp. School (spring & fall).

Wrote a letter to the NJDEP requesting information for clarification on the 50 acres of Block 7, Lot 14, an explanation of the boundary of the C1 Stream, pointing out the miss identification of a body of water, and if the water shed delineation was completed.
