## **Township Committee Minutes**

#### **January 2, 2020**

A Regular Meeting of the Kingwood Township Committee was called to order at 7:00P.M. with Mayor Ciacciarelli presiding.

Also present at the meeting were Deputy Mayor Dodds, Committeewoman Syrnick, Attorney Katrina Campbell, C.F.O. Diane Laudenbach, and Clerk Cynthia Keller. Mayor Ciacciarelli called the meeting to order and following the salute to the flag, read aloud the following:

In order to ensure full public participation in this meeting, all members of this Committee, and also members of the public are requested to speak only when recognized by the Chair so that there is no simultaneous discussion or over-talk, and further, all persons are requested to utilize the microphones which are provided for your use by the Township. Your cooperation is appreciated.

## PUBLIC COMMENT - PRIVILEGE OF THE FLOOR

David Frank, 17 Muddy Run Road – Came before the Township Committee to talk about the recycling program. He has learned that the Township had a hard time managing the center. He noted he used it in the past, but in the meantime his trash hauler does not offer recycling and feels this is a problem. Mr. Frank asked if there is anyway the Township would be able to have a smaller version for recycling. The Township Committee explained the Township still accepts metal for recycling. It was explained there were so many restrictions as to what could be recycled and funds were cut from the State. Mr. Frank asked if the Township would consider having recycling just on Saturdays with possibly having the Boy/Girl Scouts to assist the public.

Committeewoman Syrnick explained a recycling center available through Hunterdon County called the Transfer Station located at 11 Petticoat Lane, Annandale NJ, which accepts all types of recycling. She noted that the Environmental Commission talked about the recycling center for several years and really tried to make changes for the public to follow. She explained that maybe in the future the center will reopen starting out by accepting cardboard or aluminum.

The Committee Members explained it was decided to suspend the recycling center for now, but that in the future it may reopen. They would like the information for the Hunterdon County Transfer Station on the website available to the public. They thanked David Frank for coming to the meeting.

<u>Debbie Kratzer, Environmental Commission Chair</u> - Came to the meeting to explain that the NJDEP is giving away one free white oak tree to each municipality for Earth Day. She noted it is special, because it is grown from an acorn of a famous oak tree called the Salem Oak, which lived to be 100 years old.

#### "DRESS CODE POLICY"

Dress, grooming and personal hygiene must be appropriate for the position. Uniforms are required for certain jobs and are to be worn in accordance with applicable departmental standards. All other employees are required to dress in a manner that is normally acceptable in similar business establishments and consistent with applicable safety standards. Employees shall not wear suggestive or unkempt attire, athletic clothing, shorts, skirts more than three(3) inches above the knee, sneakers, T-shirts, novelty buttons, baseball hats and similar items of casual attire that do not present a businesslike appearance. Hair, sideburns, moustaches and beards must be clean, combed and neatly trimmed. Shaggy, unkempt hair is not permissible regardless of length. Tattoos and body piercing, other than earrings, may not be visible. Upon request and with the advance approval of the Clerk/Administrator, the Township may reasonably accommodate an employee's bona fide religious practice or sincerely held religious belief, so long as the accommodation does not violate safety standards or create a safety hazard. Employees violating this policy shall be required to take corrective action or will be sent home without pay.
