# **Kingwood Township Committee Minutes**

# October 6, 2022 – 7:00PM

A Regular Meeting of the Kingwood Township Committee was called to order at 7:00P.M. with Mayor Syrnick presiding. The Township Committee Meeting was in person on this date of October 6, 2022.

Also present at the meeting were Deputy Mayor Ciacciarelli, Attorney J. Moscagiuri, C.F.O. D. Laudenbach, Deputy Clerk M. Tipton-Walters and Clerk C. Keller. Committee Member Russano was absent. Mayor Syrnick called the meeting to order and following the salute to the flag, read aloud the following:

Adequate notice of this meeting was provided in accordance with the Open Public Meetings Act by publication of the notice in the Hunterdon Democrat and Courier News on January 6, 2022 and by telefaxing a copy of the notice to the Express Times on January 4, 2022. Copies of the notice were also posted in the Kingwood Township Municipal Building, Township Website and the Baptistown Post Office.

In order to ensure full public participation in this meeting, all members of this Committee, and also members of the public are requested to speak only when recognized by the Chair so that there is no simultaneous discussion or over-talk, and further, all persons are requested to utilize the microphones which are provided for your use by the Township. Your cooperation is appreciated.

There were no First Responders this evening at the meeting.

# **Public Comment – Privilege of the Floor**

<u>Rick Titchner, 457 Oak Grove Road</u> – Present to express the importance to hire an armed security officer at the Kingwood Township Elementary School. Mr. Titchner obtained 200 signatures on a petition from residents. He informed the Township Committee regarding a program the Hunterdon County Sheriff has launched called "Sheriff's Officer Class III Program." The cost for the security guard would be \$50,000 a year. Sheriff's office provides training and uniforms. Sheriff Fredrick Brown has offered to come speak to the public regarding the program at a Township meeting.

Committee Member Russano, Liaison for the Kingwood Township B.O.E was absent this evening, therefore, Mayor Syrnick recommended to send an invitation to Sheriff Brown asking if he would attend the next Township Committee meeting to give a presentation on the program. The Kingwood Township Board of Education would also be invited. This presentation will also be posted on the website for the public to attend.

<u>Holly Kachorsky and Nan Marie Hasson, Township residents</u> – Explained her address has been deemed as unsafe for the children to be picked up or dropped off by the school bus. As a single working mother, she is concerned, because the children are being dropped off in the municipal building parking lot on Oak Grove Road and need to walk home along Route 519 going north. There are no sidewalks, no shoulder and very dangerous. Speed limit is 25 miles an hour going through Baptistown, but then changes to 40 miles per hour on Route 519 right past Oak Grove Road. Came to ask if the Township could do anything to help them. Feels the speed limit should be lowered.

Deputy Mayor Ciacciarelli explained Route 519 is a county road and it is not easy to get the speed limit changed.

Mayor Syrnick suggested they attend the Kingwood Township Board of Education meeting and explain to the Board everything they discussed tonight.

The Township Committee suggested writing a letter to the Assembly and Senate members for a possible response from them. Mayor Syrnick will be writing the letter including pictures from Holly Kachorsky and Nan Marie Hasson.

<u>Mary MacConnell, Spring Hill Road</u> – Requested the information in Resolution No. 2022 -125 List of Targeted Farms and Resolution No. 2022 – 128 audit recommendations for the 2021 audit. Mayor Syrnick noted these will be taken off the Consent Agenda for discussion.

<u>Betty DeSapio, 90 Stompt Tavern Road, Historian</u> – Asked the Township Committee the plan to renovate the William Lindsay White House. Mayor Syrnick responded the Park and Recreation Committee has the responsibility to maintain the structures on park properties. Mayor Syrnick attended the Parks and Recreation meeting last evening and it was discussed to obtain bids to repair the William Lindsay White House to keep the home stable. Betty DeSapio thanked the Committee for the update.

Mayor Syrnick noted Cynthia Keller will be retiring on October 31st. She introduced new employee Tiffany Crivelli, who has been hired as the Acting Municipal Clerk. She then administered the Oath of Office to Tiffany Crivelli.

**WHEREAS**, the State of New Jersey, Department of Environmental Protection, Division of Parks, Forestry and Historic Sites Department (the "Department") is the owner of the following properties: Block 14 Lot 28.02 (consisting of a total of 137 acres); Block 14, Lot 35.01 (consisting of approximately 110 acres); Block 28, Lot 2.01 (consisting of approximately 99 acres) and Block 28, Lot 16 (consisting of approximately 50 acres) which the State acquired pursuant to N.J.S.A. 13:8A-1 et seq., "New Jersey Green Acres Land Acquisition Act of 1968; and

**WHEREAS**, the Township of Kingwood is the owner of the following properties: Block 14 Lot 30.01 (consisting of approximately 106 acres); Block 19 Lot 5.01 (consisting of approximately 82 acres); Block 12 Lot 25 (consisting of approximately 99 acres) Block 28, Lot 18 (consisting of approximately 59 acres) and Block 33, Lot 25 (consisting of approximately 105 acres); and

**WHEREAS**, all of the parcels designated in paragraphs 1 and 2 above shall hereinafter be referred to collectively as the "Properties" and grouped into the following designated areas:

- Block 14, Lot 28.02, Block 14, Lot 30.01, Block 14, Lot 35.01, Block 28, Lot 2.01, Block 28, Lot 16 and Block 28, Lot 18 (collectively known as "Horseshoe Bend Park")
- Block 12, Lot 25 (known as Horseshoe Bend Park East)
- Block 19, Lot 5.01 (known as Kingwood Township Ukarish Property)
- Block 33, Lot 25 (known as Idell Preserve); and

**WHEREAS**, historically, hunting for properly licensed hunters under the rules and regulations of the NJ Department of Environmental Protection, Division of Fish and Wildlife, has been permitted on portions of the Properties through the Township's hunting lottery and program; and

**WHEREAS**, the Township was informed by the Department that it is not authorized to permit or manage a hunting program on State owned property; and

**WHEREAS**, the Department's mandate has caused uncertainty with respect to the Township moving forward with its hunting program on Township owned land this hunting season; and

**WHEREAS**, the Township of Kingwood believes that deferring the Township hunting program for all Township owned properties for the 2022 - 2023 hunting season is advisable and in the best interest of all parties; and

**WHEREAS**, the Township currently intends to reinstate its hunting lottery and hunting program for Township owned properties next season; and

**WHEREAS**, the Township and Department are currently engaged in discussions related to permissible hunting activities on State owned lands; and

**WHEREAS**, the State has determined that bow hunting remains permissible on State owned land for the 2022 - 2023 season in accordance with State rules and regulations; and

**WHEREAS**, thirteen (13) hunters submitted payment to the Township for the deferred hunting lottery and hunting permits for the 2022 - 2023 season;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Kingwood, County of Hunterdon, State of New Jersey that the Chief Financial Officer of the Township of Kingwood shall be and hereby is authorized to refund the total amount of \$3,136.00 to the thirteen (13) impacted hunters in the manner depicted on Schedule "A" attached hereto and made a part of hereof; and

**BE IT FURTHER RESOLVED** that the hunting program shall be and hereby is deferred with respect to all Township owned property for the 2022 - 2023 hunting season.

Mayor Syrnick read aloud the ordinance by title:

This Ordinance was introduced on first reading at a meeting of the Kingwood Township Committee on the 1<sup>st</sup> day of September 2022.

The Ordinance was published in the Hunterdon County Democrat on September 8, 2022, and has been posted in the Kingwood Township Municipal Building on September 2, 2022. Copies of the Ordinance have been available for inspection by the public since September 2, 2022.

### **ORDINANCE NO. 22-11-2022**

# ORDINANCE OF THE TOWNSHIP OF KINGWOOD, COUNTY OF HUNTERDON, STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 25, INSURANCE FUNDS, TO AMEND THE EYECARE AND DENTAL COVERAGE BENEFIT PROVISIONS TO REMOVE THE \$5,000 MAXIMUM LIMIT THAT ELIGIBLE EMPLOYEES MAY BANK FOR EYECARE AND DENTAL COVERAGE BENEFITS.

**WHEREAS**, the Township of Kingwood seeks to amend the eyecare and dental coverage benefit provisions contained in Chapter 25, Insurance Funds, to remove the \$5,000 maximum limit that eligible employees may bank for future dental and vision care.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Kingwood, County of Hunterdon, State of New Jersey, as follows:

## **SECTION I**

The Township hereby amends Chapter 25, Insurance Benefits, Section 25-3, Maximum and Minimum Amount of Dental/Vision Allowance, as follows:

## §25-3. Maximum and Minimum Amount of Dental/Vision Allowance.

The Governing Body may designate the maximum or minimum amount of the Dental/Vision Allowance Fund. At the present time, the Governing Body has determined that the annual dental/vision allowance is \$1,300 per year. This amount may be "banked" by the employee for future use, year-to-year, without any limitation on the total amount which may be banked. Any unused banked funds revert back to the Township when employment ceases.

### SECTION II

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

#### **SECTION III**

If any article, section, subsection, paragraphs, phrase or sentence is, for any reason, inconsistent with the Code of the Township of Kingwood, or is held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

#### SECTION IV

This Ordinance shall take effect immediately upon final passage and publication as provided by law.

# R.S. 52:27BB-52 – A local officer or member of the local governing body

who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, and in addition shall forfeit his office.

**NOW, THEREFORE, BE IT RESOLVED** that the Township Committee of the Township of Kingwood hereby states that it has complied with N.J.A.C. 5:30-6.5 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

Condition: Limited number of personnel are response for and performing substantially all of the bookkeeping and accounting duties.

Cause: Limited staffing.

Effect: Lack of segregation of duties increases the risk that errors or defalcations, if any were to occur, would not be detected and corrected by employees in the normal course of performing their routine job functions.

Questioned costs: Not applicable.

Recommendation: Procedures should be implemented by the Municipality to reduce the risk of errors in connection with a lack of segregation of duties.

Views of responsible officials and planned corrective action (unaudited): The officials of the Municipality have determined that the Municipality is effectively and efficiently served with a single individual performing these functions. The Municipality continues to consider risk assessment as it relates to the likelihood of misstatement of financial statement amounts due to error or fraud.
